In producing herewith one arrested accused person namely Dorjee Sherpa s/o Late Angbow Sherpa of Pipeline, Near Prestige Garden, P.O Salugara, PS Bhaktinagar, Jalpaiguri along with following seized articles as per proper seizure list:

1. Eighteen (18) bottles of "60 UP PET HIMALAYAN GOLD COUNTRY SPIRIT" each bottle containing 600 ml (Total 18.8 Ltrs)

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodged a written complainant against the above Noted arrested accused person to the effect that on 06.10.2021 at 15.15 Hrs received a source information that one Dorjee Sherpa of Salugara has possessed huge no of illegal liquor at his shop styled as "Tenzing Food & Store" situated at Pipeline, Salugara uner Bhaktinagar PS for selling the same to the local customers. This refers to Bhaktinagar PS GDE No-322, Dated 06.10.2021. Accordingly, I informed I/C Bhaktinagar PS/SPC about the information. As per his kind instruction, I along with ASI Rabin Lama, C/ Mujibul Rahaman, CVF/ 619 Dharmendra Roy, CVF/Biplab Roy headed towards Salugara to work out the information. At 15.45 hrs we reached at Salugara, Pipeline and after being shown by the source I along with force held raid and search at the shop styled as "Tenzing Food & Store" and apprehend one person who disclosed his identity as Dorjee Sherpa s/o Late Angbow Sherpa of Pipeline, Near Prestige Garden, P.O Salugara, PS Bhaktinagar, and Jalpaiguri and recovered the above noted seized articles from his shop. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people illegally since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely 1] Maya Sherpa w/o Phurba Sherpa of Bikashnagar, Salugara, PS Bhaktinagar, Dist. Jalpaiguri and 2] Ravi Rai s/o Ashok kumar Rai of Bikashnagar, near Pipeline, Salugara, PS Bhaktinagar undersigned of seizure list. The seizure was made between 16.05 hrs to 16.25 hrs. I, arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I, therefore request you to kindly register a specific case against the accused person namely Dorjee Sherpa s/o Late Angbow Sherpa of PipeLine, Near Prestige Garden, P.O Salugara, PS Bhaktinagar, Jalpaiguri under proper section of law.
