Sir,

In producing herewith one accused person namely RABIN BHUJEL-40Yrs S/O LT DILIP BHUJEL OF RAJFAPRI, NEAR DURGA MANDIR PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list:

1. 32 (Thirty Two) Bottles of OLD MONK deluxe Rum (each bottle containing 750 ML)
2. 18 (Eighteen) bottles of ROYAL BLUE premium Whisky (each bottle containing 750 ML) which was kept in his bed room.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one RABIN BHUJEL-40yrs S/O LT DILIP BHUJEL OF RAJFAPRI, NEAR DURGA MANDIR PS BHAKTINAGAR DIST JALPAIGURI to the effect that on 06.10.21 at 22.20 hrs received a source information from Rajfapri near Durga Mandir under Bhaktinagar PS that one person namely Rabin Bhujel has gathered huge quantity of liquor in his house at Rajfapri near Durga Madir under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-342 dated 06.10.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 23.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession from his house. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made on 06.10.21 in between at 23.20hrs to 23.50hrs)

I therefore request you a specific case may kindly be started against the accused person namely RABIN BHUJEL-40yrs S/O LT DILIP BHUJEL OF RAJFAPRI, NEAR DURGA MANDIR PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for investigation..
