Sir,

With due respect and humble submission, I am producing herewith the arrested accused persons namely; (1) Jayprakash Yadav-32 yrs s/o Parshuram Yadav of Upper Bhanunagar near Green valley, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Sonu Mahato s/o Shadya of Upper Bhanunagar near Green vally, ward no-43 PS Bhaktinagar Dist Jalpaiguri (3) Raj Mahato-28 yrs s/o Sakaldev Mahato Upper Bhanunagar, Naya busty, near Green valley, ward no-43 PS Bhaktinagar Dist Jalpaiguri (4) Abhijit Barua s/o Lt Debu Barua of Pareshnagar ward no-44, Near PHE PS Bhaktinagar Dist Jalpaiguri (5) Pappu Yadav-25yrs s/o Kamaldev Yadav of Upper Bhanunagar, PS Bhaktinagar Dist Jalpaiguri (6) Samser Rai-42yrs s/o Lt Ganesh Rai of Pareshnagar ward no-44, Near PHE PS Bhaktinagar Dist Jalpaiguri along with following seized articles;

- 1) 95 Pcs of playing cards.
- 2) One old and used Plastic used as mat.
- 3) One used Match Box with some match sticks.
- 4) Three half burnt candle, (which were in lit up condition during raid).
- 5) Rs. 1200/ (Twelve hundred only) as Board Money.

and would like to lodge written complaint against them and also 3/4 others who fled away from the spot namely Pramod Mahato and others.

In this regard, I beg to report that on 06.10.21 at 22.10 hrs as per source information myself along with ASI Rabin Lama, ASI Dipak Karmakar, Const/374 Debraj Biswas, Const/762 Mujibul Rahaman, CVF/619 Dharmendra Roy and CVF/614 Labannomoy left PS for performing special raid against Gambling at Pareshnagar near Saw Mill (This refers to Bhaktinagar P.S. GDE No. 341 dated 06.10.21) at about 22.40 hrs reached at Pareshnagar near Saw Mill found that 10/11 persons are were engaged in Gambling by the side of Paresh Nagar main road with cards for their wrongful gain and wrongful loss, in the street light and also with the help of candles, on plastic used as matt. On seeing Police party 3 /4 persons managed to flee away after taking advantage of darkness holding some cards in their hands but 6 persons

became ferocious and started obstructing police from carrying out further legal actions and obstructed our Police team from discharging Govt. duty. On seeing their attitude, I once again told them gently, to co-operate with Police but they did not pay any heed and continued their violent attitude and used criminal force with me and my force by obstructing our vehicle to move and threatened our team with dire consequence. With no option left, I contacted I.C. Sir and apprised about the matter and as per his direction reinforcement arrived at the spot. On arrival of reinforcement, the above noted arrested persons could be calm down. I accordingly made seizure of above noted seized articles in between 23.10 hrs to 23.40 hrs u/s 10 of WBG & PC Act and arrested them u/s 41 CrPC after preparing memo of arrest and also informed them about their ground of arrest.

During preliminary enquiry, it came to learn that the following persons namely; (1) Jayprakash Yadav-32yrs s/o Parshuram Yadav of Upper Bhanunagar near Green valley, ward no-43 PS Bhaktinagar Dist Jalpaiguri (2) Sonu Mahato s/o Shadya of Upper Bhanunagar near Green vally, ward no-43 PS Bhaktinagar Dist Jalpaiguri (3) Raj Mahato-28yrs s/o Sakaldev Mahato Upper Bhanunagar, Naya busty, Near Green vally, ward no-43, PS Bhaktinagar Dist Jalpaiguri (4) Abhijit Barua s/o Lt Debu Barua of Pareshnagar ward no-44, Near PHE PS Bhaktinagar Dist Jalpaiguri (5) Pappu Yadav-25yrs s/o Kamaldev Yadav of Upper Bhanunagar, PS Bhaktinagar Dist Jalpaiguri (6) Samser Rai-42yrs s/o Lt Ganesh Rai of Pareshnagar ward no-44, Near PHE PS Bhaktinagar Dist Jalpaiguri along with 3 /4 others were gambling with two sets of playing cards for causing wrongful gain and loss to each other in exchange of money. On seeing police party 3/4 of them managed to escape but above noted arrested 6 persons started obstructing police from discharging lawful duty. On interrogation of the above noted accused persons the persons who fled away was Pramod Mahato and others.

I, therefore, pray before you kindly started specific case against the above noted persons and arranged for its investigation.
