Sir,

I would like to inform that today at around 12.30 pm while I was having my bath in the servants toilet of Block VI of Akshaytara Complex a person named Hiran Das working as a Mason in Flat No.4, of this building was making a video of me bathing through the gap between the wall and the roof from the adjacent bathroom. I came out of the bathroom to chase him shouting aloud for help. On hearing my shouts nearby people came for help and on seeing the situation started beating him.

The footage of his entry and running out of the building has been recorded in our CCTV camera. We accosted him and took his mobile phone in which we saw the video which was being forwarded to many of his contacts. One of the contacts traced was in the name of Gopal with mobile no. 9339129856 who has accepted on calling that a video has been sent on his mobile. He somehow managed to snatch his mobile phone and escaped. I also pretend that he transmitted my obscene video to other persons.

I would request you to arrest the culprit and take strictest possible action against the above person as per law. I am a widowed mother and my life will be ruined if this video becomes viral.

The above matter was narrated by Mamta Bishwakarma and written by me and admitted by her to be correct and true and signed by her.


