With due respect, I am producing herewith the arrested accused persons namely (i) Amarjit Mahato (20 yrs) S/O Maneswar Mahato of South Colony, Majdur Busty, PS- NJP, Dist.- Jalpaiguri (ii) Bablu @ Paltu Roy (30 yrs) S/O Nirmal Roy of Surya Sen Colony, Block-E, P.S.- NJP, Dist.- Jalpaiguri and (iii) Surajit Das (21 yrs) S/O Adhir Das of Surya Sen Colony, Block-D, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Bhojali from the possession of accused Bablu @ Paltu Roy S/O Nirmal Roy of Surya Sen Colony, Block-E, PS- NJP, Dist.- Jalpaiguri.
2. One sharp cutting knife and one plastic made charger torch light and from the possession of accused Surajit Das S/O Adhir Das of Surya Sen Colony, Block-D, PS- NJP, Dist.- Jalpaiguri
3. One sharp cutting knife from the possession of accused Amarjit Mahato S/O Maneswar Mahato of South Colony, Majdur Busty, PS- NJP, Dist.- Jalpaiguri.

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 07.10.21 at 00.15 hrs I received a secret source information that a gang of miscreants come at near NJP IOC Under pass under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Jabravita area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 284 dated 07.10.21. As per kind order and direction of my superior officer myself along with, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, and CV/824 Niru Yadav left for under IOC under pass to work out the information in hand. I also informed the fact to night RT Van officer SI Ganesh Roy and requested him to come near NJP under pass to accompany with us. At about 00.55 hrs on 07.10.21 we reached at IOC under pass under PS- NJP, Dist.- Jalpaiguri. After a few time SI Ganesh Roy along with force came to NJP under pass and accompany with us. At about 01.45 hrs as indicated by the source we noticed that 9/10 persons assembled in a dark place near IOC under pass and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.
