GOE NO-164/21-40 Feb, 2021 my marriage was solemnised with  
and the Marash Ghosh as per Hindu marriage and rites.  
Complaint re-  
worded to the effect that it was an arranged marriage and formally when the  
Siliguri P.O. for marriage was fixed, after that my husband 'Marash  
Started in Ghosh', my father-in-law 'Mansindra Chandra Ghosh'  
Specific case and brother-in-law 'Sandeep Ghosh' suddenly came  
as per law to our home and demanded a huge sum of money  
SI Subhendra Das invest 20 lacs rupees as dowry along with jewellery, ornaments  
gate of the value 90 lacs rupees. Since as the marriage was  
case already fixed, my father, maternal uncle and near  
relatives merged the huge amount somehow.  
Officer-In-Charge after marriage I noticed that my husband and in-laws  
Khalpara T.O.P. were not satisfied by the dowry so they further demanded  
FS, Siliguri more amount of money and 'ever' ears for themselves.  
Siliguri Metropolitan Police my sister-in-law 'Murmur Ghosh' started demanding a car  
for herself and also another car for my husband.

Nowadays, as the economical condition of my father is not well, I refused to fulfill their further demands. After my refusal, my husband and my in-laws started abusing me and started using filthy languages and did tremendous torture on me. As my father's health was not well so I did not inform any member of my parental house and tried to manage everything on my own. Thereby, I noticed my mother-in-law 'Thanna Ghosh', my father-in-law, my sister-in-law, my brother-in-law and my husband were planning conspiracy against me to do some mischievous act. My husband started torturing me physically as well as mentally on small issues. My husband used to abuse me and assault me regularly. I used to report it to my mother-in-law but she used to provoke more. My husband is a chronic alcoholic person. He used to come home late at night with his friends. His two friends namely 'Satyam Ghosh' and 'Anshadh Khan' used to abuse me and use sexual-coloured languages and even they tried to click my pictures but on my refusal my husband used to beat me in front of them. My husband is a sexual-addict person. He used to force me to do unnatural sex against my will. He always used to force me to put his private parts inside my mouth and also used to force me for anal sex. I used to shout in pain and my mother-in-law used to provoke him more and used to laugh off at all of these.

My husband and my in-law always refused my medical care. Whenever I tried to make my husband understand and questioned him about his inhuman behaviour towards me, he always answered that he will continue the same unless I fulfill all his demands. He used to discuss all of these with his friends 'Satyam Ghosh' and 'Ashraf Khan' and they used to laugh off. Once at night, after my husband slept, 'Satyam Ghosh' asked a sexual favour from me. On my refusal and protest against it, he tried to tear off my clothes, to protect myself, I pushed him and then he became furious and touched my private parts and held me forcefully. Upon which I screamed and my husband and my in-law woke up and when I told them about it, my husband and father-in-law had beaten me brutally.

During my this short span of married life, I became pregnant and my husband and my in-laws forcefully fed me pills due to which my mis-carriage took place. Fearing my inability to become a mother in future due to consumption of pills, I tried to make my husband understand and told him repeatedly to use contraceptives but he refused and used to hit me brutally whenever I tried to make him understand. On 26<sup>th</sup> June, 2021, I realised that I became pregnant again. But thinking of my health, I did not inform my husband about it but somehow he understood by my protective behaviour.



On 30th June, 2021, my husband and my mother-in-law started assaulting me and forced me to take some medicines brought by my husband which caused tremendous bleeding. As my bleeding was not stopping, I repeatedly told my husband and my in-laws to take me to doctor but they refused. As my bleeding did not stop and my physical condition was terrible, I was bound to inform my mother that time on 6th July, 2021 evening to save my life as I was on verge of death. My mother came and took me home. Seeing my tremendous condition, my father was shocked and he had a brain stroke on 6th July, 2021 and he was admitted to the hospital on 6th July, 2021 evening. Next day on 7th July, 2021, my mother took me to the doctor and after consuming the medicines prescribed by the doctor, I gradually recovered.
