resident of Ganga Nagar Road No. 2, Ward No. 5
S.M.C., P.O.-S. Ujjain Bazar, P.S. Siliguri, Distt-
Dajedjy, beg to inform you that, on dt. 03/10/21
at about 20:00 hrs, when my son, namely, Sri
Binay Kumar Yadav (18) reached at
Nepali Pally, Ganga Nagar Road No. 2, at that
time, one Sanjay Roy s/o Sri Nandu Roy,
resident of Nepali Pally, Ganga Nagar Road No.
2, Ward No. 5 S.M.C., P.O.-Siliguri Bazar, P.S. Siliguri
Distt- Dajedjy, along with 02 (two) unknown
persons, restrained my said son, Binay Kumar
Yadav (18) and attacked on him with Iron
rod and tried to kill him and stolen away
Rs. 2000/- (Rupees two thousands) only and
a Gold chain from his neck and left the place
threatening him for dire consequences.

My said son Binay Kumar Yadav (18 yrs)
received severe injury on his person and he
treated himself at Siliguri Distt. Hospital.

The above named alleged persons are
very desperate and dangerous in nature
and they may again attack my said son.

So, please take necessary action against
Sanjay Roy s/o S. Nandu Roy and his 02 (two)
unknown associates, all are of Nepali Pally,
Ganga Nagar Road No. 2, Ward No. 5 S.M.C.,
P.O.-Siliguri Bazar, P.S. Siliguri, Distt- Dajedjy.
