SUB: LODGING OF AN FIR AGAINST CRUELTY AND DOMESTIC VIOLENCE BY MY HUSBAND, HIS PARENTS AND SISTERS.

Sir,
May I bring to your kind notice the following few facts for your kind information and necessary action:-

That my marriage was solemnized according to Hindu rites and customs at my parental house mentioned below on 29-04-2007 with Shri Rajesh Hela (hereinafter referred to as alleged person) S/O. Shri Bir Singh Hela, resident of Hussainpur, Badurtola (Near Dakra Chandi Mandir), P/O. & P/S. Balurghat, District Dakshin Dinajpur and we had been cohabiting and living together peacefully till 2010 and thereafter alleged person and his family members (Parents & Sisters) began to ill-treat me and also began to physically assault me without any cause.

That I gave birth to a child in the year 2011 in Govt. hospital, Balurghat and his condition became serious and we were advised by the attending doctor/s to take child/mother to Siliguri for better treatment and accordingly we were brought and admitted in Ram Krishna Nursing Home, Sewa Sadan, Pakurtala More, Siliguri but unfortunately the child died and I came to my parental house. It is pertinent to mention here that the expenses incurred towards our treatment at said Nursing Home were borne by my mother.

That again in the year 2014, I became pregnant but there was a miscarriage and since the said miscarriage the alleged person, my parents-in-laws namely Shri Bir Singh Hela & Parvati Hela @ Paro and two sisters-in-laws namely Smt. Mani Hela (married but staying at her parental house) and Smt. Tumpa Sarkar @ Jhuma, W/O. Shri Chhotan Sarkar have also played a significant role for bringing mental and physical injury to me from time to time. That from the day of miscarriage they all began to call me a barren (BANZ) and taunting all the time and by this ill treatment I got severe mental

injury in addition to the physical torturing by the alleged person. It is important to mention here that in our Indian society barren (BANZ) is the biggest stigma and/or curse to a issue-less woman and it can only be felt by the victim. They further allege that I have miserably failed to give them their successor/s. That there's every possibility of illegal second marriage of the alleged person, as a result he has been neglecting me since last 4/5 years.

That in the month of August, 2015, I came to my parental house to celebrate RAKHI BANDHAN festival and remained there for 20/25 Days. Thereafter my brother viz. Bikram Hela contacted the alleged person over telephone at cell Nos.90845-83802 & 86375-96866 at several occasions and requested him to come to Siliguri and take back this petitioner and also asked him to forgive us if anything wrong has been committed from our side but he flatly refused and gave out that you people do whatever we want to do and he would meet us in the court of law. The alleged person and other family members always used filthy & hurtful language and threatened me of dire consequences and even he/they wouldn't hesitate to kill me if we put any type of pressure on him to take me back to my matrimonial home.

That at the time of marriage my father had to give (on demand) Gold/Silver items i.e. Necklace, Chain, Earrings, Rings-2 (Two), Nosepin, Anklet Bracelet/Nupur (Silver), Kamar Dhani (Silver- tied around the waist), Chhalla (Silver-for feet fingers), furniture consisting of wooden bed, almirah steel, dressing table, utensils of brass & kansa and in addition to this a sum of Rs.200,000 (Rupees two lakh only) and bus fare of Rs.30,000/- (Rupees thirty thousand only) from Siliguri to Balurgaht (one side).

That few years back the alleged person also started to demand of Rs.100,000/- (Rupees one lakh only) at regular intervals which my poor father couldn't fulfill and for that I had to suffer a lot. That as a last attempt and to save my matrimonial relationship I also went to my matrimonial home on 05-09-2021 but the alleged person, his parents and two said sisters didn't allow me to enter into the house and used filthy language, as result I had to come back to my parental house.

Under the above facts and circumstances, it is, therefore, prayed to take cognizance on this complaint and ensure that a FIR is registered against the alleged person, his parents and two sisters under the provision of law to meet the ends of justice & of the.

Note: Yesterday at about 7.00 p.m. I went to P/S. Siliguri for lodging of this complaint but the duty officer refused to accept this complaint and, therefore, I am constrained to submit this before your honour for appropriate action in the matter.
