assaulted today by three men unknown
to me at 6:10 pm today at Ashraupara
Siliguri near Jewel Athletic Club. I had
gone to fetch my children aged 8
years & 5 years for tuition classes.

There was an altercation regarding
parking of my car at the spot & the assault
smashed the windscreen of the car while my
small children were still seated inside the
car. Pieces of glass fell on my children
I was attacked by three people & have

Athletic Club.

Hence I pray to you to bring the culprits
to Justice.
