Sir,

1. With due respect and humble submission I would like to write few lines for your kind consideration and favourable action please.

2. We are staying at Gour Abasan, Rabindra Pally since 06 Apr, 2018. The following personnel of Gour Abasan threatened me in dire consequences on 05 Oct 2021 at around 12 o'clock and Mrs. Shashi Sharma physically abused me causing extreme pain in my arms resulting into taking injections. Along with her, her husband, Mr. Anant Kumar verbally abused me.

3. Due to above, I informed my husband who is working in Army Health Organisation. He rushed taking me to Matigara Block Hospital where the Duty Medical officer prescribed 02x injection immediately to get relief from pain.

4. We came to home and informed our neighbours to resolve the matter amicably but the above mentioned people were not ready for any reconciliation and did not give any heed to the word of Panchayat (Ex) Smt. Manju and others as well as badly behaved with all the habitants of Rabindra Pally.
5. Also, we informed the builder of Gaur Abasan to sort out the problems but he denied to have his presence due to his illness.
