I, PSI Abhishek Theengh of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one named Santosh Barman (35) to the effect that today on 07/10/2021 at 18:45 hrs while performing evening patrolling duty, received a source information that one person named Santosh Barman is selling liquor in shop situated Mirjumla, Patharghata under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction myself along with C/1035 Santosh Rabidas, C/986 Rajiv Sarkar, CV-155 Sukumar Das had been to Mirjumla, Patharghata under Matigara PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing at his shop. Subsequently, I along with my force cordoned the residence and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Santosh Barman (35) S/O- Jatin Barman of Mirjumla, Patharghata , PS-Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:25 hrs to 19:40 hrs at the spot and arrest issued memo of arrest at 19:42 hrs against him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Barman (35) S/O- Jatin Barman of Mirjumla, Patharghata , PS-Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
