In producing herewith one person namely Dilip Pradhan 42 yrs s/o Late Shyam Bahadur Pradhan of Lalit Nagar PS, Bagdogra Dist Darjeeling along with the following articles under seizure viz.

- 10 (ten) bottles of Himalyan Gold 60° Up country Spirit (each bottle containing 600 ml) marked as Exhibit "A".
- 05 (five) bottles of Kingfisher strong premium beer (each bottle containing 650 ml) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".
- 01 (one) plastic jarkin containing five liters local made Cholai marked as Exhibit "C" from which 01 liter randomly taken out as sample and marked as Exhibit "C-1".

I, ASI (UB) Jakiru Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Dilip Pradhan 42 yrs s/o Late Shyam Bahadur Pradhan of Lalit Nagar PS Bagdogra Dist Darjeeling to the effect that today i.e., on 07.10.21 at about 15:20 hrs received source information that the above mentioned person is selling illicit liquor at Lalit Nagar area from the shop cum house and huge quantity of illicit liquor is stored in his shop cum house. Accordingly, I shared the informed with you and as instructed I along with available force had been rushed to Lalit Nagar area to work out the information. On reaching there at about 17:25 hrs, after attend another information I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the shop cum house while during cordoning of the shop cum house some customers having liquor on the shop cum house and fled away. Subsequently the above noted articles were found in the shop cum house of said Dilip Pradhan who, being asked failed to produce any valid documents/papers in support of possessing and selling of the illicit liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his shop cum house under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest. The whole process of seizure and labelled was made in between 17:35 hrs to 17:55 hrs

Therefore I pray that a specific case under proper section of law may kindly be recorded against above noted Raj Dilip Pradhan 42 yrs s/o Late Shyam Bahadur Pradhan of Lalit Nagar Bagdogra Dist Darjeeling and arrange for its investigation.
