Sir/Madam,

This is to bring to your kind notice that I, Sumanta Chettri, aged 43 years, w/o Roshan Gurung, want to report being mentally tortured by my husband (Roshan Gurung, aged 53 years, s/o Lt. Pal Bahadur Gurung, r/o Opposite Nilu Atta Chaki, Ward no. 13, Punjabipara, Siliguri, West Bengal, Mobile: 9679724563) and want to file an F.I.R against him today on 06/10/21.

I was living in Shillong, Meghalaya and used to visit my sister's home here in Patharghata, Siliguri sometimes and I was introduced to my husband through a mutual friend some months back. However, due to the lockdowns, we hardly got any chance to personally interact but considering his mature age and how he presented himself to have been living like a parent figure to his siblings and relatives and believing upon whatever little information made accessible to me and my family by my husband. I agreed to the marriage.

We got married on 13/07/21 in a religious ceremonial affair at my sister's residence (Patharghata, Choto Dhukuria, near My Noodles Factory, Matigara- 734009) in the presence of my family and few of his relatives and friends. After marriage, we had been living as husband and wife in my husband's house at the above mentioned address. However, after few days of marriage, my husband started treating me inhumanely. He used to lock me inside the house whenever he used to leave the house. He had also barred me from even interacting with his family members (living separately but within the same compound) He used to scan through my phone in my absence. He has been very sceptical about me and my intentions in everything and hence even expressed his unwillingness to register our marriage because he believes that I will claim my rights on his property upon registration of our marriage. I also came to know that he has been discussing with his friends (especially Ramesh Chettri) about my chastity and disclosing even intimate details about our conjugal life through a voice recording which happened by mere chance of luck. He has also raised doubts about me having given birth to a child before getting married to him (inspite of this marriage being my first marriage) and expressed his plans for taking me for medical examinations thereby completely assassinating my character.

He has also been speaking ill of my sisters and my family. As such, I have been under continuous mental trauma since marriage. These are only few instances to mention here. Also, fearing the well-

being of my mental health and safety of my life, I was compelled to leave my matrimonial home (in the presence of my husband and mother-in-law) on 02/10/21 and taken shelter at my sister's residence.

I request you to please help for the safety of my mental health and life and register an immediate F.I.R against my husband. I will also submit the vice recording mentioned above whenever needed.
