I, Arun Kumar Goyal (Mobile no 9434257503) S/o Mahabir Prasad Goyal a resident of Flat 336, Green Valley Apartment, Upper Bhanunagar, Sevoke Road, Siliguri am also the current President of the registered society (i.e.Green Valley Welfare Society - bearing registration no S/2L/No 13932 of 2013-2014) of our above named apartment. I and my current committee has taken over from the previous committee only on 1st August 2021.

After taking over the management of the Society, it was found that a huge sum was due from the flat owners on account of monthly maintenance. It was a much needed money for some of the urgent requirements of the society.

When we approached the residents to collect the dues as shown in the society accounts, it was soon revealed to us that many members had already paid the requisite amount either fully or partially to the society and had money receipts or account transfer details as proof. This revelation came as a big

On further inquiry it became amply clear to us that Mr. Dilip Sharina (Pan No EVJPS1985J) (Aadhar No -2648 1847 6856) (last known mobile nos – 9064328047 & 7384694242) S/o Mr Fani Bhushan Sharma having his permanent address as Gidal Para, Kharia (P), Deonagar, Jalpaiguri and who was staying at Shanti, Uttar Banga Gramin Bank Building, Near Petrol Pump, Devidanga Bazar, Champasari, Siliguri, Dist. Darjeeling - and who was serving as Manager cum Accountant of our Society had forged and printed unauthorized money receipt books, had collected maintenance money from the residents vide these unauthorized money receipts.

It may also be noted that we have some residents who do not permanently stay in our society and pay the maintenance dues by transferring money directly into the bank account of the society. The said Mr. Dilip Sharma had approached some of these flat owners and citing some problem with the society account fooled them into transferring money into his own personal account.

It may be noted that till date we have been able to trace an embezzlement to the tune of Rs.13,32,525/= (Rupees thirteen lakhs thirty two thousand five hundred twenty five only) from the various members of the society on account of maintenance dues alone. Also to be noted is the fact that this amount may increase once we are able to reconcile the dues of the flat owners who generally stay outstation.

It is also pertinent to bring to your kind notice that Mr. Dilip Sharma has been working in the society for past six-seven years and as such had earned the trust of the flat owners. It has also been brought to our notice that he had also collected some amount as personal loan from the flat owners/residents of our society due to this misplaced trust. He had taken a leave from 28th January 2021 and has not been coming since then. At this juncture we are not sure who all are involved in this embezzlement along with Mr. Dilip Sharma.

It is our earnest request to you to kindly investigate this matter thoroughly and take appropriate legal action against all involved and recover the money of our society for which the entire society shall remain ever obliged.
