Sir,

I PSI. Agen Lepcha of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 07.10.2021 at 20:05 hrs I received a information from my reliable source that one vehicle bearing Reg. No. WB 73 A 3210 loaded with stolen river bed materials coming from Matigara, Sutki Goadwan Side . On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Matigara near Sutki Godwan under Matigara P.S area, I found one vehicle bearing Reg. No. WB 73 A 3210 loaded with river bed materials going towards Patitamjote area. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle under proper section of law and arrange for its investigation.
