I, SI Subhash Ch Roy of Bagdogra Traffic Guard , SPC lodged a written complainant against the above noted accused persons to the effect that today i.e. on 08.10.2021 Vide BDR TG GDE NO 65 in course of performing lock down traffic duty at NBMC Gate under Matigara PS, Siliguri Police Commissionerate in order to restrict the unnecessary movement of vehicular traffic for combating the spread of Covid-19, and I detained the following persons plying their e-Rikshwa without any valid reason the alleged person did not pay any heed toward Police and was moving freely at the above noted place and thereby violating the Lockdown order issued by the MHA, Central Govt. and State Govt. with the view to contain the spread of pandemic Covid-19[.] Accordingly I seized their e-Rikshwa u/s 102 Cr. P.C and arrested them U/s 41 C.r.P.C under proper memo of arrest after explaining charge against them.
