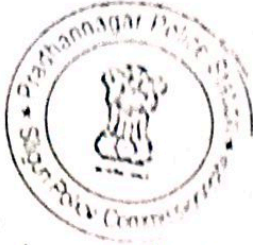

Sir,

In producing here with four arrested persons namely 1) Md Akhtar (28), S/O- Majja Mohammad of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling, 2) Md Safikul @ Takla (230, S/O- Lt Md Nur Islam of do, 3) Shiva Barman @ Baw (21), S/O- Dilip Barman of Durgaguri, Kalibari road, P.S. Pradhan nagar, Dist- Darjeeling, 4) Hassan Raja @ Subrata (20), S/O- Lt Md Alauddin of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling, along with seized articles (i) One iron made sword measuring about 30 inch (Approx) including wooden handle, recovered from the possession of Md Akhtar, (ii) One Iron Rod measuring about 37 inch (Approx), recover from the possession of Md Safikul, (iii) One Iron Rod measuring about 33 inch (Approx), recover from the possession of Shiva Barman, (iv) One Steel made Chopper measuring about 12 inch (Approx) from the possession of Hassan Raja @ Subrata, (v) One big size yellow colour torch light recovered from the possession of Hassan Raja @ Subrata, along with seizure note and connected papers.

IASI Ashit Singha of Pradhan nagar P.S./SPC do here by lodged the complaint against the above miscreants that, Today i.e. 06.10.21 at 23.20 hrs I received an information from source that 10/12 miscreants armed with deadly weapons assembled below Mahananda Bridge, Champasari under Pradhan Nagar P.S. and preparing themselves to commit 'Dacoity' at Baghajatin Colony under Pradhan nagar P.S. area. Accordingly I shared the information with you and accordingly as per your kind direction at 23.30 hrs myself along with SI Haren Mohanta, ASI Ratan Pradhan, PSI Sumit Sarkar, PSI Kalyan Saha, CV/645 Pankaj Gupta, CV/223 Swapan Chetri, CV-128 Ajay Sahani proceeded to the place vide Pradhan nagar P.S. GDE No 397, Date 06.10.2021, to work on the information, I also informed the R.T. Mobile Officer to assist us. R.T. Mobile Officer SI Pratap Basak and Const/417 R. N. Das, C/476 Jagat Ch Roy proceeded for assisting us.

At about 23.40 hrs we reached near Champasari Mahananda Bridge and met with my source there and he corroborated the information again. Afterwards we proceeded towards the spot on foot and we found 10/12 persons were sitting below Mahananda Bridge. But on seeing the police party they started to flee away in multiple direction. However, we managed to apprehend 04 (four) persons namely 1) Md Akhtar (28), S/O- Majja Mohammad of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling, 2) Md Safikul @ Takla (230, S/O- Lt Md Nur Islam of do, 3) Shiva Barman @ Baw (21), S/O- Dilip Barman of Durgaguri, Kalibari road, P.S. Pradhan nagar, Dist- Darjeeling, 4) Hassan Raja @ Subrata (20), S/O- Lt Md Alauddin of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling. Other accused persons were managed to fled away from the spot. On search the apprehended accused persons, I recovered (i) One iron made sword measuring about 30 inch (Approx) including wooden handle, recovered from the possession of Md Akhtar, (ii) One Iron Rod measuring about 37 inch (Approx), recover from the possession of Md Safikul, (iii) One Iron Rod measuring about 33 inch (Approx), recover from the possession of Shiva Barman, (iv) One Steel made Chopper measuring about 12 inch (Approx) from the possession of Hassan Raja @ Subrata, (v) One big size yellow colour torch light recovered from

the possession of Hassan Raja @, Subrata. Accordingly I seized the recovered articles under proper seizure list. The seizure was made in between 00.45 hrs to 02.40 hrs. On interrogation the apprehended accused persons disclosed that they along with their associated gathered on the place to commit 'Dacoity' at Baghajatin Colony area. I accordingly arrested the said accused persons, issuing Memo of Arrest after that conducted raid in criminal den and adjacent area to apprehend the other 7/8 associates leading to their statements. Then I brought the accused persons to Pradhan Nagar PS and produce before duty officer along with all seized articles and relevant papers.

So, I therefore pray before you that a case U/S- 399/402 IPC may kindly be started against the miscreants namely 1) Md Akhtar (28), S/O- Majja Mohammad of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling, 2) Md Safikul @ Takla (230, S/O- Lt Md Nur Islam of do, 3) Shiva Barman @ Baw (21), S/O- Dilip Barman of Durgaguri, Kalibari road, P.S. Pradhan nagar, Dist- Darjeeling, 4) Hassan Raja @, Subrata (20), S/O- Lt Md Alauddin of Mallaguri, Ratanlal busty, P.S. Pradhan nagar, Dist- Darjeeling, along with 7/8 other miscreants and arrange for its investigation.
