Sub: Complaint against my husband namely Sri Arindam Banerjee.

Sir,

I, Smt. Tumpa Banerjee, Wife of Sri Arindam Banerjee, residing at Subhashpally Bazar, Rathkhola, P.O. Rabindra Sarani, P.S.- Siliguri, District- Darjeeling, Pin- 734006 would like to lodge this complaint to the effect that on 10/03/2010 my marriage was solemnized with Sri Arindam Banerjee, Son of Sri Shibani Prasad Banerjee, as per Hindu Rites and Customs. Out of our wedlock one male child was born namely Nilesh Banerjee on 12.01.2017. After the commencement of our marriage my husband's behavior towards me started to seem indifferent. In the first instance my husband started to abuse me with inappropriate words by demanding cash from my parent's house. Thereafter after the lapse of 2 to 3 months my husband started to assault me physically after coming home being intoxicated. My husband does not co-operate in any of the household chores not does he spend a single second with his son. My husband used to take money from my hard earned which I had to save for my son's livelihood but my husband used to forcefully take those cash from me. For several months my husband's brutal behavior towards me continued to be the same. Whenever I used to deny my husband to get cash from my father my husband used to assault me by slapping me and with kicks and blows. On several nights my husband used to come home at late night and through me out of the house for the entire night without any reason. Moreover my husband on several times used to lock the main door from outside and take away the key with him keeping me and my children inside the house. My marital life continued to remain the same for several years. On several occasion I was compelled to call the police personals at my house after being brutally assaulted by my husband and every single time my husband used to apologies for his deed but his behavior upon me remained the same.

Today morning at 10 am in the morning my husband started to demand cash from me and when I denied giving him the same assaulted me tremendously by pulling my hair and punches before the eye of my minor son. I was treated at Siliguri Sadar Hospital. My son aged about 4 years 10 months became horrified by witnessing such acts of his father. My husband tried to out shed me and my child from the house and finding no other alternative I am compelled to lodge this complaint before you.

Kindly take the necessary action and do the needful and obliged me.
