I beg to report that today effect that on  
14.10.2021 at around 00.35 hrs I along with ASI-Dilip Sarkar,  
ASI-Suhanta KR. Das, ASI-Biswajit Saha, Cnt 1122-Sanjit Kar,  
cv-537-Bijay chanda, cv-739-Bikash Nagesia, cv-745-  
Pradip Singha, cv-249-Ganesh Barman, 662 Jyotish Singha,  
cv-767-Aishwariya of Bagdogra TG under Siliguri Police Com.  
engaged my traffic duty in the Dwaga Puja Festival -2021 at  
Mayadevi Club and Gate under Matigara PS. During performing  
my traffic duties I notice that O/C BDR TG. I along with  
ASI Biswajit Saha went to near to O/C BDR TG. And I came  
to know that he was talking wrong side entry and O/C  
BDR TG obstructed him not to go along wrong side. But he  
was trying to go forcefully from wrong side, he involved  
with strong allegation. Then we behaved politely and  
fan out from their. In the mean time he returned back along  
the same way side to go from wrong side. At that time O/C  
ordered us not to giving him to go along wrong side, with  
Right Side. He went along the right side threatening us to  
see ourself.

After around 15 minits he returned with some body  
giving him identification as a secretary of Mayadevi Club and  
showed on our self rude behaves. Among them one person  
of Mayadevi club hit on my chin using strong language. At that  
time some body was calling the name of "Bony" from the side.  
So that he will have escape from the place.

So, this is my earnestly request to take necessary  
steps against offender. So that nobody can take un-lawful  
steps against police persons to performe their own duties.
