I, Debasmita Sur Biswas, wife of Kanchan Biswas, resident of South Deshbandhupara, Near pipeline, P.O & P.S- Siliguri, Dist- Darjeeling, aged about 33 yrs, beg to state that I have married with Sri. Kanchan Biswas, son of Sri. Kamalendu Biswas on 2<sup>nd</sup> March 2017 at the Bikash Bhawan, near Agrani Sangha, Bhaktinagar, jalpaiguri. From the said wedlock one child is born namely Pritika Biswas on 03/2/2018 at Siliguri. When I conceived the child my husband, father in law (Sri. Kamalendu Biswas), mother-in-law (Smt. Kalyani Biswas) and brother-in- law (Sri. Ranjan Biswas) ordered me to abort the child. And with the instigation of my sister -in -law (Kanika Sarkar) and her husband (Samir Sarkar) always instigated and also joined my husband to torture me mentally and physically. They always criticised and cursed me and my parents about the quality of things given by my parents during the time of marriage. They used to use very filthy, abusive and slang language towards me. During my pregnancy each and every day my husband tortured me with the instigation of my mother-in- law, father-in -law and brother -in- laws. My mother -in law administered some medicines in my food for forced miscarriage of my child, I denied taking any medicine from her without proper verifications from doctor. Then she told me that the medicine is to abort the child. denied to abort the child and gave birth of a girl child namely Pritika Biswas. As I gave birth of the girl child at Ramkrishna Nursing home, Siliguri, my husband and his other family members denied taking me back at their house with the girl child. From the Nursing home I went to my father's house at Deshbandhupara,

Siliguri where I residing presently. My husband came to my father's house but never showed his interest to take me at their house with my girl child. When I asked him that when he shall take us at my matrimonial home? He stated that his parents are not ready to take her with the child. My husband worked in the tourism company and spent most of his time away from home neglected all kinds of responsibility towards me. They treated me as the maid of the house and subjected me to rigorous household worked even during my pregnancy knowing that I am not physically fit.

That on 4<sup>th</sup> October 2021 he called me and told me to meet him at about 6.45 p.m in YMA ground at Babupara, Siliguri and I met him and asked him about the maintenance amount for me and my daughter but he abused me verbally with very offensive, filthy and abusive language and threatened me to make the life of my daughter and me hell. He also threatened to kill me and my daughter if I would seek any legal help. He further told me that he would not give me single penny for my daughter or me.

Madam I am a victim of prolonged Domestic Violence caused by my husband and his family members and I along with my daughter are passing our days in extreme fear and anxiety.

Therefore Madam, I will be highly grateful to you if you investigate into the matter and kindly please take appropriate strong legal action against my husband as per the provision of law and oblige me thereby.
