While he was taking a leak, a man approaches me, tries to talk, when ignored, snatches my phone, and beats me and tried to snatch my purse.

When my fiancé saw and started running towards me, the person had fled ~~undisturbed~~ and ~~talless~~ shelter in a shop near my house. People came and found him and beat him, but he managed to escape. I have later come to know from my local neighbourhood that he is a staff of Babul's meat shop near Champasani More beside a temple.

I have injuries on my head, knees and hands.
