Roy, are working in the travel agency "Mount Blue Tour & Travel" opposite of Manila Hotel. Came to me and started hitting me, and giving me abusive languages. In this scenario i have received injury along with a cut in my left upper eye, of which a medical copy is been enclosed. I have lost a cash of Rs 3200/- [Three Thousand Two Hundred], along with a small gold chain around my neck, and the injury that i have.

So, my request to you is that those men, are of great threat to me, along with the other counter staff are also been harras by them.
