producing herewith one(01) arrested accused person namely Md. Entajul @ Nandu Bao, S/Ofalim of Millat Nagar, Dry Fish Market, PO+ PS- Matigara, Dist- Darjeeling (not verified) along with following articles under proper seizure;

i) One transparent plastic packet containing total 285 grams brown sugar which was kept inside right side pocket of trousers of Md. Entajul @ Nandu Bao and marked as "Exhibit- A" ii) One transparent plastic packet containing 20 grams brown sugar taken as sample from exhibit "A" for examination and marked as Exhibit "A-1"

iii) Cash rupees 1,71,010/- [Rupees One Lakh Seventy one thousand and seventy rupees] only in Indian Currency Note in the following denomination :- Rs. 500 X 47 =23,500, Rs. 200 X 127 = 25,400/-, Rs. $100 \times 876 = 87,600/$ -, Rs. $50 \times 600 = 30,000/$ -, Rs. $20 \times 116=2320$, Rs. $10 \times 225=2,250$ [Total = 171010/- (Rupees One Lakh Seventy one thousand and seventy) only and marked as 'Exibit-B'.

iv) One steel colour portable weight machine and marked as 'Exibit-C'.

v) One steel colour KECHAODA keypad mobile phone having IMEI No. 862625047631032 and 86265047631040 and connection No. Airtel-9932496492/8695277670(VODA) and marked as Exhibit D

vi) One Golden colour Screen-touch OPPO Mobile phoe having IMEI No. 861171034093077 and

861171034093069 and connection no. 8099821180 (Airtel) and marked as 'Exhibit E' (SL. No. iii & SL. No. iv was kept inside a multi-colour nylon bag which was kept in the Right hand of Md. Entajul @ Nandu Bao ; SL No. v and SL. No. vi was found inside the left pocket of Trousers of Md. Entajul @ Nandu Bao)

I, PSI Shekhar Adhikary (31), S/O- Lt. Sonatan Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Md. Entajul @ Nandu Bao, S/O-Md. Halim of Millat Nagar, Dry Fish Market, PO+ PS-Matigara, Dist- Darjeeling (not verified) to the effect that today on 16.10.2021 at about 16.35 hrs I received a specific source input that one person was standing at Matigara Hospital More, under Matigara PS with huge quantity of Brown Sugar for delivering the same to their designed customers at the adjacent areas. The matter was diarized in Matigara PS GDE No. 956, Dt- 16.10.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with PSI Newton Biswas, Const- 1008 Kanak Roy, Const- 986 Rajib Sarkar and CV/387 Sukumar Barman all of Matigara PS, SPC along with investigation kit left for Matigara Hospital More, under Matigara PS by govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 957 Dt- 16.10.2021 and M.C.C No-481/21 Date- 16.10.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Matigara Hospital More, I contacted two persons namely 1) Reeju Khan (39) S/O Lt. Riyaj Khan, and 2) Parimal Sarkar (43) S/O Lt. Brojen Sarkar both of Beldangi, Tumba Jote, PO + PS Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses noted above reached at Matigara Hospital More, under Matigara PS at 17.15 hrs and being pointed by my reliable source approached towards one person standing at Matigara Hospital More with a multi colour nylon bag. At that time seeing the Police party approaching towards him he started fled away from the spot but, however we managed to apprehend him. Thereafter, we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he has illegally possessed brown sugar for selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. At this he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Matigara Hospital More, under Matigara PS to remain present and to supervise the search and seizure. Accordingly at 18.05 hrs Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Matigara Hospital More as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Md. Entajul @ Nandu Bao. Further, on demand in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained person namely Md. Entajul @ Nandu Bao failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found 285 grams of brown sugar kept in a transparent plastic packet which was kept inside right side pocket of trousers of accused Md. Entajul @ Nandu Bao and marked as "Exhibit- A". I also taken 20 grams of Brown Sugar from the packet as sample for examination and marked as "Exhibit A-1". Accordingly, I seized the above noted articles from the exclusive and conscious possession of accused namely Md. Entajul @ Nandu Bao at the spot at Matigara Hospital More under proper seizure list in presence of independent witnesses and Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person. Subsequently, I labeled and sealed the seized articles in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person. The whole process of seizure was made in between 18.15 hrs. to 19.35 hrs.

Being further asked, the apprehended person namely Md. Entajul @ Nandu Bao admitted in presence of Shri Narendra Kalicotay, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he has procured the brown sugar clandestinely from Malda and Lalgola side for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of brown sugar illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Md. Entajul @ Nandu Bao is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Md. Entajul @ Nandu Bao after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Md. Entajul @ Nandu Bao, S/O-Md. Halim of Millat Nagar, Dry Fish Market, PO+ PS- Matigara, Dist- Darjeeling (not verified) and arrange for its investigation.
