I, Smt. Dipali Majumdar (52) w/o Sri Mukul Majumdar, resident of Natarpara (Near Dabgonde primary school), ward no. 5 some, P.O. Siliguri, Distt - Darjeeling, beg to inform you that on dt. 12.10.2021 at about 09-30 am, when my old aged mother namely, Smt. Rajeshwari Mondal (81 yrs) w/o Late Gurendas Mondal, of above noted, was coming back to her home and reached in front of her house, at that time ~~at~~ her neighbors namely, Rahul Roy S/O of Bhupen Roy, of Natarpara (Near Shant Mandar) ward no. 5 some, P.O. - Siliguri Darjeeling, Distt - Darjeeling, started abusing my mother when she said that why he always spread her stones, (which is kept for construction of her house), by driving his 4 (four) wheelers vehicle over it. Then said Rahul Roy, ~~scattered~~ ~~my~~ ~~and~~ ~~took~~ ~~in~~ ~~inside~~ ~~her~~ ~~house~~, dragging her, and after that my said mother became un-healthy and immediately shifted to Siliguri Distt. Hospital and there she was declared brought dead by the concerned doctors, of Siliguri Distt. Hospital, and kept her dead body at Morgue of Siliguri Distt. Hospital for her further post mortem and etc.

So, I am very unhappy with the sudden death of my said old aged mother and I am sure that her neighbors Rahul Roy S/O - Bhupen Roy of Natarpara (Near Shant Mandar) ward no. 5 some, P.S. Siliguri, forceful actions with my mother, caused her death, so please take necessary action against said Rahul Roy.
