Sub: Written complaint against Ajay Bhagat S/O Lt.Chanua Bhagat, Sasti Bhagat(Bura) S/O Lt. Chanua Bhagat, Munna Bhagat S/O Lt.Jalua Bhagat and another 13-14 persons along with Jamai of Ajay Bhagat of Milanpally near RBS club Under P.S Siliguri Dist:Darjeeling.

Sir,

With due respect I Sri Ananda Dhar S/O Lt. Narayan Chandra Dhar of Milanpally,Nilkantha Apartment near RBS Club under P.S Siliguri Dist:Darjeeling Would like to draw your kind attention to the following effect that today at about 12-12.15A.M the aforesaid person knocked our door of our flat and after opening the door the aforesaid Ajay Bhagat,Sasti Bhagat,Muna Bhagat and their Jamai and along with another 1/2 persons forcibly entered our flat by pushing my wife Maya Dhar and my Pregnant Daughter Neha Dhar and they also enter our flat with weapons (Knief,Sword,sticks),and some of them with drunken condition and snatched 3 golden chain from the neck of me, my wife and my daughter Neha Dhar and they also snatched one pair of golden designer conch(sakha) from the hands of my wife and they extorted more gold and money by putting fear of death showing the said weapons when my son in law requested them to leave our flat then they became more violent and they jointly attacked us and they also caught the hair of my pregnant daughter and my daughter fell down and hit her lower abdomen by saying that they want to kill her unborn baby because they are not getting proper gold and money. In the mean time said Munna Bhagat caught the hand of my younger daughter Tina Dhar and also beat her and committed the outrage of modesty and they also tried to kill me and pressed my neck with intention to kill me at that time out of fear my wife delivered an amount of 15000 in the hands of Ajay Bhagat they also gave life threat to us. there after the aforesaid persons left the apartment and went away after ransacking. Presently my Pregnant daughter Neha Dhar is suffering severe Lower Abdominal Pain. The Medical Paper is also annexed with this complain as annexure 1 and the medical paper of mine is also annexed with this complaint as annexure 2. Presently we are in trauma for their violence and life threat. It is pertinent to mention that the aforesaid persons created a terror in our locality.

Therefore you are requested to take immediate legal actions against them as per law and also try to recover the gold chains and ornaments and the amount.
