In producing herewith one (01) arrested person who disclosed her identities namely Rajeswari Modlier (50 yrs) W/O Sri Devid Modlier of Bandle Balikata near Shitala Mandir, PS- Chunchura, Dist- Hooghly along with the following seized articles . seized under proper seizure list, duly attached herewith viz :

- i) One (01) Carton Box of "GLENCOFF-C" Cough Syrup (CODEINE PHOSPHATE & CHLORPHENIRAMINE MELATE SYRUP) containing 40 bottles @ 100 ml each wrapped with white Cello tape having batch no. GNS21001 marked as Exhibit-A,
- ii) Two bottles of "GLENCOFF-C" Cough Syrup (CODEINE PHOSPHATE & CHLORPHENIRAMINE MELATE SYRUP) containing 100 ml each taken as sample from the exhibit-A and marked as Exhibits-A1.

I, SI Uday Chakraborty of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against Rajeswari Modlier (50 yrs) W/O Sri Devid Modlier of Bandle Balikata near Shitala Mandir, PS- Chunchura, Dist- Hooghly to the effect that on today ie on 16.10.21 at 14.15 hrs I have received a specific source information that one female person is standing with carton box containing huge quantity of contraband Cough Syrup at Timulpara more under Ward No. 04, Siliguri for disposing the same for her wrongful gain. The matter has been diarized vide Siliguri PS GDE No.1023 Dt- 16.10.21. Accordingly, I informed the matter to Sri Sudip Chakraborty , Inspector-in-Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information, accordingly he directed to me to work out the information immediately. Hence at about 14.35 hrs as per his kind direction myself along with PSI Rajiv Subba, ASI Siben Sarkar, ASI Subir Sen, ASI Dhruva Mishra, LC/1313 Mili Roy, LCV/175 Pratima Das, CV/283 Prosenjit Dey and CV/622 Ramanth Barman all of Siliguri Police Station, Siliguri Police Commissionerate left for Timulpara more to verify the veracity of the information vide M C C. No. 406/21 Dt. 16.10.21 which refers to GDE No. 1026 Dt. 16.10.21 by Govt. Vehicle No. WB 61A0137 driven by CV/285 Krishna Yadav.

At the time of departure from PS, I took envelope, white paper, sealing wax, gum, seal, etc. At about 14.45 hrs we reached at Jhanker more & kept our vehicles

at a distant. Subsequently we called two independent witnesses namely; (1) Sanjay Sahani (36) S/O Sri Suresh Sahani of Santoshi Nagar near Radha Krishna Mandir, Ward no. 05, PS- Siliguri, Dist- Darjeeling and (2) Suraj Yadav (21) S/O Sri Binod Yadav of do and disclosed our identities and informed them about the information in hand and requested them in writing to accompany us to witness the Police action. They agreed & gave in writing about their consent to accompany Police during the raid.

Then, as per source information, we approached towards Timulpara more & as per identification by source I managed to cordoned the place and found that the above noted person was standing there with carrying a Carton box. Accordingly we detained her.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained person was carrying contraband Cough Syrup in her exclusive possession for disposing the same at Timulpara more in concealed manner for supplying/ selling the same in Siliguri and its adjacent area for her wrongful gain. On being asked she disclosed her identity as noted above and admitted that she possessed contraband Cough Syrup. Then I gave her option in written whether she wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. She agreed to be searched by one of them. Further, I served her option notice in accordance with provisions of law in this regard in writing and she also gave her approval of being searched by any one of them in writing on the notice served to her. Then I informed the matter to I.C.Siliguri PS & I requested him to come at Timulpara more to remain present and supervise the search, seizure and label being a Gazetted Police officer. Accordingly, at 15.45 hrs Sri Sudip Chakraborty, I. C. Siliguri PS arrived at the spot in uniform and disclosed his identity to the detained person as well as to the witnesses as a Gazetted Police Officer. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But she refused to search the police party. Under supervision of Sri Sudip Chakraborty, Inspector -In-charge, of Siliguri Police Station, SPC and in presence of two independent and dis-interested public witnesses and with help of lady force, searched the detained person following all formalities keeping her decency but nothing could be recovered on her person except her wearing apparels. Then, I opened the one carton box and found that the above seizure articles kept concealed in the said carton box wrapped with plastic which is not visible from the outside. Then the detained person confessed that she was carrying these box in concealed manner for selling/supplying to young boys at Timulpara more and its adjacent area. On demand in presence of the Gazetted Police Officer, Sri Sudip Chakraborty, I. C. Siliguri PS, she failed to produce any valid document in support of possessing of the said contraband Cough Syrup which was holding by her.

Accordingly I counted the said Cartoon box containing Cough Syrup, which was found in the possession of the above noted detained person and found total 40 bottles of "GLENCOFF-C" Cough Syrup (CODEINE PHOSPHATE & CHLORPHENIRAMINE MELATE SYRUP) containing 100 ml each marked as Exhibit- A, and also collected two bottles of said contraband Cough Syrup containing 100 ml each as sample taken from Exhibits A and marked as Exhibits A1. Then, I seized the above noted articles under proper seizure list and labeled, duly signed by the above noted witnesses, Police personnel and the Gazetted Police Officer, Sri Sudip Chakraborty and duly acknowledged by the detained person. I also supplied a copy of seizure list to the detained person. The whole search, seizure & label was made in between 15.50 hrs and 17.00 hrs. On further asked the apprehended person confessed in presence of Gazetted Police Officer, Sri Sudip Chakraborty, LC Siliguri PS and other witnesses that she procured the said seized Cough Syrup from Prodhan Nagar area for the purpose of illicit gain. On interrogation she disclosed that she had been dealing in such business of selling the said Cough Syrup illegally since long. Then I arrested the above noted accused person after observing all guidelines of Apex court.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely; Rajeswari Modlier (50 yrs) W/O Sri Devid Modlier of Bandle Balikata near Shitala Mandir, PS- Chunchura, Dist- Hooghly.
