With due respect, I SI (UB) Hiru Kanti Sarkar of in charge of Bagdogra Airport Out Post under Bagdogra PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the following persons namely i) Mahendra Limboo ii) Tapan Dey iii) Uttam Das iv) Shilfen Toppo v) Swapnil Sarkar vi) Uttam Gope vii) Nitish Singha viii) Sanjay Sarkar ix) Joydev Roy x) Santu Sarkar xi) Atanu Sarkar xii) Pintu Ghosh xiii) Goutam Singha xiv) Subash Barman Rashan Barak xv) Durga Biswakarma xvi) Bikash Karmakar xvii) Ashim Kar all of taxi driver of Bagdogra Airport under PS, Bagdogra Dist, Darjeeling for unnecessary harassment of bona fide passengers and discharging the public servant from his Govt. duty.

To the effect that on 15.10.2021 around 10.45 hrs, while myself along with force was performing Govt. duty at Bagdogra Airport maximum passengers de-boarding from upcoming various flights to go to their different destination places the above noted taxi drivers made a hesitation and obstruction to the bona fide passengers to demand of their contract carriage passenger vehicle fare which has not been revised since 2011. Seeing the same we requested them and asked to be more co-operative with tourist and stop unnecessary harassment of the bona fide passengers. So that passenger's movement from Bagdogra Airport is not hampered and law and order situation is not taken place. Over this issue

I, repeatedly tried to make them understand but the above noted persons further called another their associates drivers then and there 15/20 others came at the spot joined with aggressive mood and obstructed the police personnel to discharge of Govt. duties.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
