Subject: Information regarding theft incident at Freshia-1

Respected Sir,

I (Sunder Sharma) s/o Sh. L.R. Sharma resident of Punjabi Para Ward No. 13, Siliguri working as manager at Freshia-1 a residential complex at Debidanga, Champaran, Siliguri would like to inform you that on 15.10.2021 around 1 PM in the afternoon 2 persons entered in our complex stating to the guard that they are catering person. But after entering the complex they tried to steal heavy iron blocks which are used in lift machine, but due to presence of the residents in ground floor as Dusga Puja celebration was going on, they were unable to steal the blocks of iron and were caught. As they were 2 persons, one was successful to escape from the spot and the other was caught. The one who is caught is the resident of Bortala near Champaran. The iron blocks which were tried to steal is of around 3 quintals in quantity having commercial value of Rs 1,50,000/- (approx.). We had informed the respective Thana regarding the incident.

So, we request you to kindly look into the matter and take necessary action so that such type of incident does not take place in future.
