### Reasons for delay in reporting by the Complainant / Information

(1) 18 (eighteen) numbers white colour nylon bags each bag containing 140 bundles of illegal contraband chochlet fire creekers each bundle containing 06 packets total 840 packets i.e. 18 x 840 = 15,120 packets of illegal chochlet fire creekers style as "Mantu Chocolate" weighing 70 kgs each bag. Total weighing 70x18 = 1260 kgs (2) 09(Nine) numbers white colour nylon bags each bag containing 70 (Seventy) bundles of illegal contraband chochlet fire creekers each bundle containing 12 packets x 70 = total 840 packets i.e. 09 x 840 = 7,560 packets of illegal chochlet fire creekers style as "Fancy Big Chocolate" weighing 70 kgs each bag. Total weighing 70x9 = 630 Kgs. (3) 09(Nine) numbers white colour nylon bags each bag containing 140 bundles of illegal contraband chochlet fire creekers each bundle containing 140 packets x 05 = total 700 packets i.e. 09 x 700 = 6,300 packets of illegal chochlet fire creekers style as "Fancy Big Chocolate" weighing 70 kgs each bag. Total weighing 70x9 = 630 Kgs. (4) 02 (Two) paper made cartoon each cartoon containing 32 big packets of Magic WEINKLE SOUND i.e. total 32x4 = 64 big packets, each big packets containing 50 small box i.e. total 64x50 = 3200 packets weighing 20 kgs each cartoon. Total weighing 20x2 40 Kgs. (5) 01 (one) 12 wheeler truck displaying number plate JK/03/E/3303.

Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Soukat Ahamed (40 yrs) S/O Abdul Rahim & (ii) Ashik Hussain (23 yrs) S/O Abdul Rahim both of Vill- Betengu, PS- Anand Nag, Dist.- Anand Nag, Jammu & Kashmir and the following articles under seizure :-

1. 18 (eighteen) numbers white colour nilon bag each nilon bag containing 140 bundle of illegal contraband Chocklet fire crackers, each bundle containing 06 packets of Chocklet fire crackers i.e. total  $(140 \times 06) = 840$  packets of Chocklet fire crackers i.e.  $(18 \times 840) = 15,120$  packets of illegal contraband Chocklate fire crackers styled as "Mantu Chocklate" and each nilon bag containing total 70 kgs of illegal contraband fire crackers i.e. total  $(18 \text{ bags} \times 70 \text{ kg}) = 1260 \text{ kg}$ .
2. 09 (nine) numbers white colour nilon bag each nilon bag containing 70 (seventy) bundle of illegal contraband Chocklet fire crackers, each bundle containing 12 packets of Chocklet fire crackers i.e. total  $(70 \times 12) = 840$  packets of illegal contraband Chocklet fire crackers i.e.  $(09 \times 840) = 7,560$  packets of illegal contraband Chocklate fire crackers styled as "Fancy Big Chocolate" and each nilon bag containing total 70 kgs of illegal contraband fire crackers i.e. total  $(09 \text{ bags} \times 70 \text{ kg}) = 630 \text{ kg}$ .
3. 09 (nine) numbers white colour nilon bag each nilon bag containing 140 (one hundred forty) bundle of illegal contraband Chocklet fire crackers, each bundle containing 05 packets of Chocklet fire crackers i.e. total  $(140 \times 05) = 700$  packets of illegal contraband Chocklet fire crackers i.e.  $(09 \times 700) = 6300$  packets of illegal contraband Chocklate fire crackers styled as "J.K'S SPIDERMAN" Chocolate and each nilon bag containing total 70 kgs of illegal contraband fire crackers i.e. total  $(09 \text{ bags} \times 70 \text{ kg}) = 630 \text{ kg}$ .
4. 02 (two) paper made cartoon each cartoon containing 32 (thirty two) big packet of Magic WRINKLE SOUND i.e. total  $(32 \times 2) = 64$  big packets of Magic WRINKLE SOUND and each big packet containing 50 small box of WRINKLE SOUND i.e. total  $(64 \times 50) = 3200$  packets of small box containing WRINKLE SOUND and each cartoon containing total 20 kgs of illegal contraband fire crackers i.e. total  $(02 \text{ bags} \times 20 \text{ kg}) = 40 \text{ kg}$ .
5. One 12 wheeler truck displaying number plate JK/03/E/3303.

I, SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate do hereby lodged the written complaint against the above noted arrested accused persons to the effect that today i.e. on 13.10.21 at 16.05 hrs I received a secret information that one truck having registration number JK/03/E/3303 loaded with illegal contraband fire crackers was coming from Ghosh Pukur side. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East-II, SPC and diarized the fact in General diary vide NJP PS GDE No 592 dated 13.10.21. As per kind order and direction of my superior officers myself along with others available officers and force namely VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, and CV/824 Niru Yadav left for Fulbari Toll Plaza to work out the information in hand. I also informed the fact to RT Van officer ASI Aranya Binoy Das and requested him to come Fulbari Toll Plaza to accompany with us. At about 16.25 hrs on 13.10.21 we arrived at Fulbari Toll Plaza and started Naka checking.
