Sir,

I Smt. Dipsikha Sarkar (Jana), wife of Samrat Sarkar, resident of P.C sarkar Sarani, Hakimpara, Siliguri, and Darjeeling beg to state that I am a resident of Ushajyoti Apartment since long. Yesterday on 17/10/21 at about 8-00 Pm one Smt. Annapurna Singh w/o Ratul Malakar employee of Durga Hundai, Dagapur (near DPS school), along with Riya Malakar, w/o Sovan Paul, and Shovan paul, resident of shivrampally, BBD Sarani, meghlal Roy road, hyderpara, came in front of my apartment and restrained my path when I came from outside and started to sue filthy languages against me and my husband. When I asked the reason for such behaviour, they started to molest me and threatened me that they will kidnap my son if we allow Sri Ratul Malakar (husband of Annapurna Singh) to our house. We inform the local police verbally and return back to our flat at about 11-00 pm. When we reached at our flat we saw that the above named accused persons and some other antisocial are waiting in front of our flat and started to assault me and my son and husband. I became seriously ill. My left eye got injured grievously. They snatch my gold chain. They tried to kill me and my child but my husband saved us. They started to assault my husband also. My husband called the police and police rescued us. My husband took me at Siliguri dist. hospital.

Therefore I will be highly grateful to you if you investigate into the matter and kindly take appropriate strong legal action against accused persons as per the provision of law and oblige me thereby.
