With due regards, I, **SMT. ANANYA DEBDAS**, Wife of Sri Pintu Das, Resident of Matigara New Colony, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling, in the State of West Bengal, would like to inform you that my marriage was solemnized on 25.08.2005 with **SRI PINTU DAS**, Son of Sri Benu Kumar Das, of Matigara New Colony, Matigara, P.O. & P.S. Matigara, Dist. Darjeeling, according to the Hindu Rites and Customs on and from the maternal uncle's house of my husband at Debpara, Banarhat, Dist. Jalpaiguri and the said marriage was the outcome of our previous love and affairs.

After my marriage, I, along with my husband have started to live and co-habited together as husband and wife at my matrimonial house as mentioned aforesaid along with my other in laws members and we have passed our martial life happily for a period of few months. At the time of our marriage, my husband was engaged himself in a Private Job and the income which he earns was not sufficient to maintain ourselves and accordingly with the permission of my husband and other in laws members, I started to work in order to co-operate and maintain our family smoothly though I used to perform all my household chores in the family.

Immediately after engaging myself in the different job, my husband and in laws members namely Smt. Anita Das, brother-in-law Sri Khokan Das, his wife Smt. Sukla Das, my married sister-in-law Smt. Sandhya Das, have started to cause mental and physical torture upon me in different ways. Though our marriage was the outcome of our love and affairs, but after elapse of six months, my parents and other family members have duly accepted our said marriage and have given so many valuable articles including furniture & fixtures, golden jewelries, and other household articles to my husband and his family members with their full satisfaction in order to maintain peace and harmony in my matrimonial house.

Inspite of fulfilling all the demands of my husband and in laws members, they were not satisfied and showed their dissatisfaction over

the articles and always taunting about the same and I being a newly married wife, used to bear all such type of torture of my husband and in laws members with a hope that in near future they will definitely realized their own mistake and rectify themselves but all hopes have gone in vain due to their continuous mental and physical torture upon me.

In the mean time, I became pregnant and during my pregnancy period, they have not stopped their torture upon me. They did not provide sufficient food to me and they also did not take any care upon my health and they treated me just like a maid servant. I being a Hindu wife always tried to satisfy themselves according to my best and inspite of that, they were not satisfied.

I also noticed that my husband and my brother-in-law are habitual drunker and they have a good nexus with the anti social persons and everyday, they were returning home in late hours with fully drunken condition and immediately after entering into the house, they started to assault and humiliate me without any just cause and reason with an intention to ruin my life permanently.

Sir, one male child was born on 09.10.2010 out of our wedlock, whose name is Master Subhodip Das and after the birth of the said child, I think that they will change their attitude and behavior but later it was proved that my thinking was wrong. Sir, whatever I used to earn from my private service, I handed over the major portion of my income to my husband and in laws members in order to run our family smoothly. In the year of 2013, I have joined in the Civic Volunteer Services under West Bengal Police Department and still now I have been performing the said job with sincerity and honesty.

Though my married sister-in-law namely Smt. Sandhya Hore Das has been living separately but almost every day, she used to come in the early morning at 7 / 7.30 A.M. and stayed till 9 P.M. and she always provoked and abetted my husband and other in laws members to commit torture upon me, so that, I voluntarily left my matrimonial house and she flatly stated that after driven out me from my matrimonial house, they again negotiate the marriage of my husband with another lady and will earn huge dowry. On several occasion my husband and my other in laws members in conspiracy with each other tried to destroy my life but due to my alert, they could not succeed their plan. As and when the husband of my married sister-in-law namely Sri Pintu Das raised his

voice and objection against their said illegal acts and try to helped me so that, I can live in my matrimonial house peacefully, but they did not bother to hear the request of my said brother-in-law and on contrary, they started to spread rumors that there was an extra marital relation in between myself and my said brother-in-law Sri Pintu Das and they started to threaten me and my said brother-in-law that if we will talk with each other, then they will murder us. There are so many instance of torture of my husband and in laws member upon me which, I have captured in my mobile phone.

Since last one year, they started tremendous mental and physical torture upon me and asked me to bring a some of Rs. 5,00,000/- only from my parental house and if I fail to bring the said amount, my husband will commit suicide and implicate me in a false criminal case. One day, after completion of my work, when I return to my house, I found that my husband is taking alcohol in the bedroom though he used to consume medicine as his leg fractured in a accident and seeing the same, when I raised objection, the other in laws members in conspiracy with my husband started torture me and while I went to a member self help group for my signature as I am also engaged in the said group, one of my neighbor called me and told me that there was a big gathering in front of my matrimonial house and immediately after returning there from, his family members have started to blame me that my husband tried to commit suicide by way of hanging due to me and subsequently, I realized that the entire incident is a big drama and in a pre planned manner, they are trying to oust me from my matrimonial house and try to implicate me in a false case.

On 05.10.2021, after completion of my work, I went to market with the consent of my husband in order to purchase some cloths and belongings for my minor son and after completion of marketing, when I return back to my matrimonial house, my husband and my mother-in-law started to create torture upon me and when I raised my objection, they became more furious and asked me to leave their house immediately and when I refused to leave their house, my husband and my mother-in-law started to beat me mercilessly with a view to kill me in presence of my minor son and when I started to hue and cry, they left me and also threatened me that if I will not leave their house, they will not hesitate to ruin my life and due to their said inhuman assault, I have

received severe injury on my person. Finding no other alternative, on 06.10.2021, I have compelled to leave my matrimonial house with my minor son and took shelter at my parental house and thereafter, I went to Siliguri District Hospital, Siliguri and treated myself and the attending Doctor after examining me, prescribed some medicines and since then, I have been residing at my parental house with my minor son.

During my stay at my parental house, I have been receiving several threatening phone calls from the side of my husband and his family members and asked me to return back to my matrimonial house only to do the household works in my matrimonial house and when I refused to return back, my husband threatened me with dire consequences by saying that if I did not return back to my matrimonial house, he will commit suicide by hanging himself and implicate me in a false criminal case and put me behind the iron bar and also threatened me that prior hanging himself, he will throw Acid on my face and ruin my entire life. Due to their such type of illegal activities and threatening, I have been passing my days in my parental house with mental pain, fear and anxiety and I also apprehend that they will not hesitate to create some untoward incident in order to ruin my life.
