I, ASI Tapan Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Dulal Roy (44/M) S/O Late Mukunda Roy of Himul, Nagrujote, P.O- Nemaï, PS- Matigara, Dist- Darjeeling under arrest along with following seized articles viz : 10 (Ten) liters of local made illicit Liquor (Chullu) and marked as "Exhibit-A" for examination and 01 (one) liter of local made illicit Liquor (Chullu) taken from "Exhibit-A" for examination and marked as "Exhibit-A-1" under seizure list (which is enclosed herewith) to the effect that on 21.10.2021 during my Evening Raid Duty received a secret source information that one person namely Dulal Roy has stored huge quantity of liquor at his residential house at Himul, Nagrujote, under PS- Matigara without any valid license. Diarized the matter vide Matigara PS GDE No. 1016 Dt.-21.10.2021 accordingly I, informed the matter to O/C Matigara PS. and as per kind direction of O/C Matigara PS, myself along with ASI Nitai Mandal, Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Nagrujote, Himul to verify the veracity of the source information. On reaching at the spot it was found that huge quantity of local made illicit Liquor (Chullu) stored in the house of Dulal Roy who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Dulal Roy. There after I called two independent witnesses namely i) Chandan Roy (24) S/O Keshab Roy of Nagrujote, Himul, PS- Matigara, Dist- Darjeeling(ii) Samir Roy (26) S/O Tapas Roy of Nagrujote, Himul, PS- Matigara, Dist- Darjeeling and in the very presence of those witnesses I, search the house and seized the above noted liquors and after preparing proper seizure List in presence of two independent witnesses and duly signed by them and apprehend the person namely Dulal Roy. On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 21.10.21 in between 20:05 hrs to 20:35 hrs. Label was also prepared against total seized articles on the spot. I then arrested the accused Person namely Dulal Roy (44/M) S/O Late Mukunda Roy of Himul, Nagrujote, P.O- Nemaï, PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of local made illicit Liquor (Chullu) at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Dulal Roy (44/M) S/O Late Mukunda Roy of Himul, Nagrujote, P.O- Nemaï, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
