Haiderpara, Ananda Mayee Kalibari Road, Under SMC Ward number 40,  
P.S. Bhaktinagar, Dist. Jalpaiguri do hereby lodge this FIR on the following  
effects with the request for taking immediate action -

- 1) That I am an old ailing senior citizen person aged about 74 year is  
facing acute problem for unwarranted torture caused my son Sri  
Purnendu Sarkar and by his wife Smt. <sup>(LIPA)</sup> Lipa Majhi (Sarkar) and for  
the redressal of the said torture I have no other option than to take  
shelter before you for initiating necessary proceeding against my son  
and daughter - in - law under the provision of Senior Citizenship Act  
and also for other panel offences.
- 2) That since long years I and my wife Smt. Bishakha Sarkar are being  
tortured both mentally and also sometimes physically so as to grab  
my only residential property situated at Haiderpara, Siliguri and at  
present the said torture has reached to each an extent that I am not  
in a position to bear further.
- 3) Sir, off and on my son is threatening me with dire consequences if I do  
not transfer my residential property in their name voluntarily forever  
and on refusal, my son sometimes assaulted me and at present if my  
son and my daughter in - law are not driven out from my house they  
will murder me and my wife as such I humbly request you to take the  
matter very seriously so as to protect my life as well as to protect the  
life of my wife, I further state that since my boyhood bit by bit after  
working hold I had accumulated a fund in cash approx Rs. 4,00,000/-

and because of the unwarranted torture and pressure of my son I had been compelled to pay the said amount to my said son in cash for starting business and at the time of taking the said money from me, my son assured me that he will provide monthly maintenance to me and to my wife out of the business with my fund but unfortunately nothing is being paid by my son and as a result I and my wife are in acute crisis to pull our life and moreover for want of money sometimes I and my wife pass our days with starvation and hence, I do request you to take appropriate step to evict by son namely Sri Purnendu Sarkar and his wife <sup>Lipa</sup> ~~Nita~~ Majhi from my house immediately by starting necessary proceedings and also do the needful so that I and my wife can get monthly maintained from my above named son.
