In producing herewith one arrested accused person namely Pappu Tiwari (31) s/o Trilok Tiwari of Baba hotel, Near Biswanath More, Prakash Nagar, PS Bhaktinagar, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. Five (05) Bottles of Kingfisher Strong Premium Beer (each bottle containing 650 ml.).
2. Seventeen (17) Bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 300 ml.).

I, ASI Rabin Lama of Bhaktinagar PS, SPC would like to lodged a written complaint against the above noted arrested accused person to the effect that on 22.10.2021 at 19.25 Hrs during evening patrolling duty received a source information that one Pappu Tiwari of Prakash Nagar has gathered huge amount of liquor illegally in his shop named and styled as "BABA HOTEL" situated at Biswanath More under Bhaktinagar PS for selling the same to the customer for his wrongful gain. Accordingly, I, informed I/C Bhaktinagar PS/SPC about the information over phone and as per his kind instruction, I, along with, C/374 Debraj Biswas CVF/ 014 Labanyamoy Barman headed towards Biswanath More to work out the information. I, along with force reached at Biswanath More, and after being identified by the source I along with force entered the aforesaid Hotel and apprehend one person who disclosed his identity as Pappu Tiwari (31) s/o Trilok Tiwari of Baba hotel, Near Biswanath More, Prakash Nagar, PS Bhaktinagar, Dist. Jalpaiguri and held raid in his Hotel and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local customer since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely 1] Raju Paswan s/o Late Mangu PAswan of Puja Car Decora, Prakashnagar, Near Biswanath More, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri., 2] Prabhat Prasad s/o Ram Prasad of Vivekananda Nagar, Near Health Centre, Ward No. 42, PS Bhaktinagar, Dist. Jalpaiguri undersigned of seizure list. The seizure was made between 18.55 hrs to 19.25 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to register a specific case may kindly be started against the accused person namely Pappu Tiwari (31) s/o Trilok Tiwari of Baba hotel, Near Biswanath More, Prakash Nagar, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
