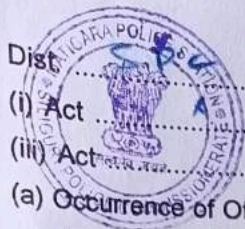

Sir,

In producing herewith one accused person named Sudip Sundas (45), S/O-Madan Sundas of Patharghata No. 2 More, PO- New Chumta, PS -Matigara, Dist - Darjeeling under arrest along with following articles under proper seizure.

1/ 15 Liters of ID Liquor named as Chullu and marked as "exhibit A" ii/ 01 Liters of ID Liquor named as Chullu taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1".

I, PSI Abhishek Theengh of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Sudip Sundas (45), S/O-Madan Sundas of Patharghata No. 2 More, PO- New Chumta, PS -Matigara, Dist - Darjeeling to the effect that today on 23.10.2021 at 20.05 hrs received a source information that one person named is selling liquor in a shop situated at Patharghata More under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction I along with C/1035 Santosh Rabidas, C/986 Rajiv Sarkar, and CV-155 Sukumar Das had been to Patharghata More under Matigara PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing ID liquor at his house. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found in the said house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned ID liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Sudip Sundas (45), S/O-Madan Sundas of Patharghata No. 2 More, PO- New Chumta, PS -Matigara, Dist - Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:55 hrs to 21:25 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Sudip Sundas (45), S/O-Madan Sundas of Patharghata No. 2 More, PO- New Chumta, PS -Matigara, Dist - Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
