Sir,

With due respect and humble submission, in producing herewith one accused namely Sunil Sahani (32) S/O Balo Sahani of Coolie Para, PS. Pradhan Nagar, Dist-Darjeeling under arrest along with following articles under proper seizure;

- i) 04 (Four) bottles of Prakash 60up Country Spirit each bottle 300ml.
- ii) 14 (fourteen) Bottles of Himalayan Gold 60up each bottle 600ml

I PSI. Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 19.10.21 when I was performing Mobile van duty along with force vide PDN PS GDE NO 1080 19.10.21. During mobile patrolling I received an information that one person namely Sunil Sahani S/O Balo Sahani of Coolie Para, Ps. Pradhan Nagar, Dist-Djg has storage huge quantity of illegal liquor in his petty shop situated below Mahananda Bridge near shamshan ghat under Pradhannagar PS and selling the same in his shop. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the above noted person and on being search his shop recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 15:45hrs to 16:15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sunil Sahani (32) S/O Balo Sahani of Coolie Para, Ps. Pradhan Nagar, Dist-Djg and arrange for its investigation.
