With due respect and humble submission, in producing herewith one female accused namely Shanti Lama W/O Lt.Nirmal Lama of Near Siliguri Junction, Ps, Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 21(Twenty one) bottles of King fisher strong bear each bottle of 650ml.
- ii) 10(Ten) bottles of Emboss fine Whiskey each bottle 750ml
- iii) 6(Six)Cosmos fifty xxxrUM EACH BOTTLE 750ml.
- IV) 16(Sixteen)Mc Dowel no1 pouch packet each packet 180ml.
- V) 19(Nineteen) bottles MC.DOWEL NO.1 RUM each bottle 180ml.
- vi) 12(Twelve)bottles of Himalayan Gold each bottle of 600ml.

I SI.Pratap Basak of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 19.10.21 I along force with L/C 1263 Sujata Thapa was performing mobile vide PDN PS GDE NO 1078 19.10.21 .During mobile van duty I received an information that one person namely Shanti Lama W/O Lt.Nirmal Lama of Near Siliguri Junction, Ps, Pradhan Nagar, Dtg has storage huge quantity of illegal liquor in her shop situated near Siliguri Junction styled as Durga Restaurant cum hotel under Pradhannagar PS and selling the same in her shop .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the above noted person and on being search her shop recovered above noted articles , On demand she failed to produce any valid document in respect of recovered articles .On interrogation she admitted that she is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 15:35hrs to 16:35 hrs and I arrested her keeping her modesty with the help of Lady constable.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Shanti Lama W/O Lt.Nirmal Lama of Near Siliguri Junction, Ps, Pradhan Nagar, Dtg and arrange for its investigation.
