With due respect and humble submission, in producing herewith one accused namely Suraj Sah(19) S/O Biren Sah of Rajendra Nagar Coolie Para,Ps Pradhan Nagar,Dist. Darjeeling under arrest along with following articles under proper seizure

- i)4(four) bottles of Officer Choice whisky each bottle 750ml..
- ii)10(ten) Pouch packet Officer choice whiskey each pouch packet 180ml
- iii) 04(four) bottles of Mc. Dewel no. 1 xxx Rum each bottle 750ml.
- iv) 08(EIGHT) Bottles of Mc.Dewel xxx Rum each bottle of 180 ml

I SI Haren Kr Mohanto of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 19.10.21 vide PDN PS GDE NO 1089 19.10.21 while I was performing spl raid duty with CV/128 Ajay Kr Sahani,CV/223 Swapan Chettri ,I received an information that one person namely Suraj Sah S/O Biren Sha of Rajendra Nagar Coolie Para,Ps Pradhan Nagar,Dist.Darjeeling has storage huge quantity of illegal liquor in his petty shop situated below Mahananda Bridge near shamshan ghat under Pradhannagar PS and selling the same in his shop .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the above noted person and on being search his shop recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 16:35hrs to 17:15hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Suraj Sah(19) S/O Biren Sah of Rajendra Nagar Coolie Para,Ps Pradhan Nagar,Dist.darjeeling and arrange for its investigation.
