With due respect and humble submission, in producing herewith one accused namely Mahesh Singh(50) S/O Lt. Ram Bilash Singh of near SBI Champasari, Ps.Pradhan Nagar, Dlg under arrest along with following articles under proper seizure ;

- i) 8(eight)bottles of King fisher strong bear each bottle of 6.50ml.
- ii) 9(nine)bottles of Himalayan Gold 60up each bottle 600 ml

I SI. Haren Kumar Mohanta of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 20.10.21 when I along with CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri was performing Special Raid duty vide PDN PS GDE NO 1149 20.10.21 .I received an information that one person namely Mahesh Sing(50) S/O Lt. Ram Bilash Singh of near SBI Champasari, Ps. Pradhan Nagar, Dlg has storage huge quantity of illegal liquor in his petty shop situated near Super market gate under Pradhannagar PS and selling the same in his shop. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the above noted person and on being search his shop recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 16:35hrsto 17:30 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Mahesh Sing(50) S/O Lt. Ram Bilash Singh of near SBI Champasari, Ps.Pradhan Nagar, Dlg and arrange for its investigation.
