With due respect, I am producing herewith the arrested accused person, namely Mithun Das (38 yrs) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No.35, PS. NJP, Dist. Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him:

1. 12 (Twelve) bottles of HAYWARDS - 5000 Super strong Beer containing 650 ML in each bottle.
2. 12 (Twelve) bottles KINGFISHER Strong Premium Beer containing 650 ML in each bottle.
3. 03 (Three) bottles of Oliver's Choice Blue Prime Grain Whisky Containing 180 ML in each bottle.
4. 03 (Three) bottles of IMPERIAL BLUE Classic Grain Whisky containing 180 ML in each bottle.
5. 03 (Three) bottles Mc Dowell's No 1 Superior Whisky containing 180 ML in each bottle.
6. 05 (Five) bottles TOBRORG Strong Premium Beer containing 650 ML in each bottle.
7. 14 (Fourteen) bottles of Himalayan Gold Counties Spirit containing 600 ML in each bottle.

I, SI Goutam Mallik, presently attached with NJP PS under your kind control, beg to state that today i.e. on 21.10.21 at 14.30 hrs I received a secret source information that one person namely Mithun Das is selling I/D liquor illegally at his shop styled as Ganesh Hotel at IOC Gate, PS. NJP, Dist. Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 908 dated 21.10.21 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, VP/08 Laxman all of NJP PS, SPC left for Hotel Lane, NJP to work out the information in hand. At about 14.55 hrs we arrived at Ganesh Hotel, IOC Gate, PS. NJP, Dist. Jalpaiguri and being shown and identified by the source I held raid at Ganesh Hotel and managed to apprehended the owner of the said hotel. During interrogation he disclosed his identity as noted above and also disclosed that he is selling I/D liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 14.30 to 16.15 hrs on 21.10.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mithun Das (38 yrs) S/O late Ganesh Das of Bhakti Nagar Pipe Line, Ward No.35, PS. NJP, Dist. Jalpaiguri and arrange for its investigation.
