Subject: Intimation regarding harassment and tremendous mental torture.

Respected Sir,

This is inform you that I, Miss Subhashree Das, daughter of Mrs Minakshi Das, a resident of Deshbandhu Para, Siliguri, West Bengal is continuously been harassed and mentally tortured by a boy since 2 years.

I met Mr Avinash Prasad Paswan, son of Mr Nandlal Prasad Paswan, a resident of Santinagar, Siliguri, West Bengal in the year 2012 in our school. Gradually we became good friends and shared a co-ordinal relationship. With growing time, we started visiting each other's family and we stood behind each other in times of need. While visiting his house, his parents claimed that he was very stubborn and arrogant and didn't pay hid to any of them and they felt that he only listens to me so I should take his responsibility and try to bring him in "Good Path". And even I gave my level best effort to make him responsible and career oriented, so that he leads a good life. After spending some quality time, we had decided that in near future we will be together and we had informed the same to our family.

Avinash always had the habit of lying and I tried hard to change this habit of him. Since 12th January 2019 things changed between us, He started lying and cheating on me. Almost all of his lies were caught red handed and was informed to him with proves. Every time he asked me to forgive him and assured me and my family that he would not repeat the incident because he knew that if he ever faces any problem in life I will stand behind him no matter what, especially during monetary issues. But as per his habit he continued lying.

After a certain period of time we had several issues between us for his friends and his habit of drinking Alcohol and lying. Avinash always wanted me to be isolated. He didn't like me keeping contact with any of my friends and co-workers, but he would do everything he wanted no matter I like or dislike the same. Avinash is very short tempered and doesn't have control on his actions when he is angry. There have been many a times when during my office hours he visited my office and created scenes. Gradually with time, his actions became more aggressive. He would not mind creating scenes anywhere. He would slang and shout on me at public places and at times we

had physical fights too. As things were getting worse day by day and I could not manage the stress of his mental tortures I had decided to not continue the relationship anymore in the month of October 2019. He contacted and convinced me to meet him on 2nd of January 2020. After the meeting he had assured me that he would not continue his previous habits and would freshly start the relationship again. Even I thought of giving him another chance. Things were going pretty well then but after few months he again started cheating and lying. We would have fights almost every day and I was having a mental breakdown. His behavior towards me changed tremendously. He was like an unknown person to me by now. During the beginning of 2021 I started distancing myself from him as I wanted to lead a peaceful life.

This is when his mental tortures started very dangerously. He would come and wait near my office, despite the fact I didn't wish to meet him. If I tried ignoring him then by using public transport to reach my destination, he would stop the vehicle in middle of the road and would force me to get down. As I was afraid of any scene created by him in public, I would have to get down and go with him. He would frequently message me that he would harm himself if I don't talk to him and meet him. At times he became aggressive too. I had clearly said him that I didn't wish to be with him anymore as I could not handle his lies, aggressiveness and his threats. Things became worse when he started stalking me everywhere. He would enquire about me in my work place and in my neighborhood.

During the mid of August 2021, my family took the decision about my marriage so that I get rid of this life I was leading. Avinash got to know about this and on 21st of September 2021 he handed over an envelope with empty sleeping pills box to a local store near my house and messaged me that he was ending his life. I had received a call from one of his friend working in Anadolok hospital that I was the person who was responsible for his condition and forwarded me his videos and images from the hospital. After he came back from hospital, again he started stalking me. He would stand at night near my house and would ask my neighbors about me, throw letters inside my house, kept calling me, messaging me, telling me that he would die, etc, etc. Even I have received messages from his father Mr Nandalal Prasad Paswan's number claiming that I was responsible for his son's condition.

On 16th of October 2021, at around 9 pm, the guy with whom I might get married had come to visit my house. This is when he saw Avinash waiting outside my place. As Avinash saw him entering my house he came behind him and forcefully entered my house and started shouting outside. My 69 years old grandmother was scared of his behavior and asked him to get inside and speak as all my neighbors could hear him shouting out loudly and on top he was drunk. He started banging his hands on walls and gates and then finally came inside the room. He was not ready to accept the fact that I moved on and he has no possession over me. After a brief discussion he said he would

not disturb me anymore and left the house at around 9:50 pm. After he left I immediately informed his mother, Mrs Sabitri Prasad about what Avinash had done. This was not the first time when I informed his family that he was bothering me and my family, but multiple times earlier too I had informed her and requested her to take necessary action against her son.

At around 12:30 am the same night I received a message from Avinash that he has kept a bag of gifts that was given to him by me inside my house garden, which means he jumped over the boundary wall of my house and came inside. Then I received a series of messages from his number requesting me to go outside and take the bag. When I didn't do so, at around 2 am again he messaged me stating that he kept the bag near the main entrance of my house, which means again he jumped over the wall and entered my house. At 2:43 am I received multiple calls from an unknown number claiming that he is Avinash's friend and Avinash was going to end his life and I am the only person who could stop him. Even a number of calls and messages were done by Avinash too after that. Finally to ignore all the chaos, I switched off my number.

The next morning, on 17th October 2021 when I switched on my mobile I received message from Mrs Sabitri Prasad at around 7:40 am that Avinash is dead. To confirm the news my sister called Mr Nandalal Prasad at around 10:00 am and he said that Avinash had jumped from Rontong hill and they were tensed about the same. At around the same time his youngest brother Atish Prasad posted in instagram requesting his elder brother to come back soon where ever he was. Members from the same family had contradictory statements. One of Avinash's friend, at around 5:30 pm had messaged me the same day that he was missing till then. And on 18th of October the same person messaged me that he was found by police and is very serious.

Now Sir, I would humbly request you to take necessary action against Avinash Prasad Paswan and rescue me and my family members out of this situation. I am not been able to lead a normal life as we all are scared of Avinash and his inappropriate actions. This whole thing is also affecting my work life and things are getting tough as I am only the earning member of my family.
