Sir,

In producing herewith one accused person namely SURESH RANA-60YRS S/O LT JAGBIR RANA C/O PURNIMA LAMA OF GOWALABUSTY, WARD NO-43, PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list:

1. 03 (Three) pet Bottles of Himalayan Gold 60up country spirit each bottle containing 600 ML)
2. 12 (Twelve) bottles of KINGFISHER strong Beer each bottle containing 650 ML)
3. 02 (two) pet Bottles of Himalayan Gold 60up country spirit each bottle containing 300 ML) which was kept in his street hotel.

I beg to report that I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one SURESH RANA-60YRS S/O LT JAGBIR RANA C/O PURNIMA LAMA OF GOWALABUSTY, WARD NO-43, PS BHAKTINAGAR DIST JALPAIGURI to the effect that on 25.10.21 at 22.45 hrs received a source information from near Alishan Hotel under Bhaktinagar PS that one person namely Suresh Rana has gathered huge quantity of liquor in his street hotel under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1435 dated 25.10.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 22.55 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession from his ~~house~~ hotel. During local enquiry it came to learn that he is selling the same in open market long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made on 25.10.21 in between at 23.05 hrs to 23.30 hrs)

I therefore request you a specific case may kindly be started against the accused person namely SURESH RANA-60YRS S/O LT JAGBIR RANA C/O PURNIMA LAMA OF GOWALABUSTY, WARD NO-43, PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for investigation..
