Sir,

In producing herewith one arrested accused person namely AVINASH CHHETRI-25YRS S/O PRADIP CHHETRI OF JYOTINAGAR, NEAR PATESWARI HIGH SCHOOL, PS BHAKTINAGAR DIST JALPAIGURI along with following seized articles viz:

1. 19 (Nineteen) packets of JUGMUG chocolate Junior fire crackers each packet containing 12 pieces total-228 pieces (Electric sound)
2. 01 packet of BURIMARS chocolate fire crackers containing 12 pieces manufactured B.M Works.
3. 10 (ten) packets of CHUT PUTU fire crackers each packet containing 10 pieces total -100 Pcs. Manufactured by VADIVEL PYROTECHS, SHIVAKASI
4. 08 (eight) packets of POP MAGIC TRICK fire crackers each packet containing 20 pcs.
5. 50 (Fifty) packets of GOLDEN KING COBRA electric crackers each packet containing 28 pcs manufactured by THAMARA KANNAN FIRE WORKS, SIVAKASI.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 27.10.21 at 20.15 hrs received secret source information that one person stored and selling banned fire crackers at his Grocery shop at ITI road near Vidyasagar club under Bhaktinagar PS. Diarized the information in GD vide Bhaktinagar PS GDE no-1529 dated 27.10.21 and at 20.20 hrs as per your kind instruction myself along with ASI Dipak Karmakar, Const/374 Debraj Biswas, Const/762 Mujibul Rahaman, CVF/614 Sumit Kumar Roy, CVF/014 Lanonnomoy Barman left for ITI road to work out the information.

At about 20.35 hrs we reached at ITI road, sometimes after, being identified by the source our police party held raid in the shop of Avinash Chhetri and recovered the above noted articles from his shop. On demand he could not produce any valid documents/license in support of said fire crackers and also stated that he was selling the band fire crackers in his shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by them and accused person from the possession of Avinash Chhetri and arrested him u/s 41 Cr.pc. (The seizure was made in between 20.50 hrs & 21.40 hrs)

I therefore request you a specific case may kindly be started against the accused person namely AVINASH CHHETRI-25YRS S/O PRADIP CHHETRI OF JYOTINAGAR, NEAR PATESWARI HIGH SCHOOL, PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for its investigation.
