On producing herewith one accused person namely KARTICK HALDER-23YRS S/O LT NARESH HALDER OF EKTIASAL HAT NEAR PIPE LINE PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list:

- 17 (seventeen) no's of pet bottles of Himalayan Gold 60up country spirit (each bottle containing 600ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs- 1700/- (One thousand seven hundred only)
- 10 (ten) no's of pet bottles of Himalayan Gold 60up country spirit (each bottle containing 600ML in each bottle mentioning M.R.P of Rs- 60/- in each bottle i.e. total amount of Rs- 600/- (Six hundred only). All the articles packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one KARTICK HALDER-23YRS S/O LT NARESH HALDER OF EKTIASAL HAT NEAR PIPE LINE PS BHAKTINAGAR DIST JALPAIGURI to the effect that on 24.10.21 at 16.40 hrs received a source information from Ektiasal Hat under Bhaktinagar PS that one person namely Kartick Halder has gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. Deterred the fact in GDE side Bhaktinagar PS GDE No-1364 dated 24.10.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 17.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 17.20 hrs to 18.10hrs)

I therefore request you a specific case may kindly be started against the accused person namely KARTICK HALDER-23YRS S/O LT NARESH HALDER OF EKTIASAL HAT NEAR PIPE LINE PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for investigation.
