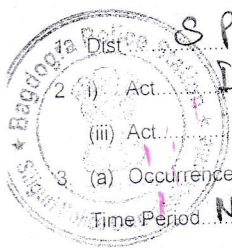

Respected Sir,


