In producing herewith one person namely Sunil Karmakar (28) S/O Mangru Karmakar of lichu pakri PS Fansidewa District Darjeeling along with the following articles under seizure viz.

1. 25 (twenty five) bottles of Himalyan Gold 60° Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1".
2. 03 (three) bottles of Kingfisher strong premium beer (each bottle containing 650 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".

I, ASI (UB) Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Sunil Karmakar (28) S/O Mangru Karmakar of lichu pakri PS Fansidewa District Darjeeling to the effect that today i.e., on 27.10.21 at evening about 17.45 hrs received secret source information that the above noted arrested person is selling illicit liquor at Rangapani Bazar area from his shop styled as Raj Hotel and huge quantity of illicit liquor is stored in his shop. Accordingly, I shared the informed, with you and as per your kind direction, I along with available force had been rushed to the Rangapani Bazar area to work out the information. On reaching there at about 18.35 hrs, I contacted with my source and subsequently being pointed the apprehended above noted person who being asked disclosed his identity as above and stated that he is the owner of the shop (Raj Hotel) during cordoning of the said shop some customers having liquor on the shop and fled away. Subsequently the above noted articles were found on the Raj Hotel of Sunil Karmakar who, being asked failed to produce any valid documents/papers in support of possessing and selling of the illicit liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the above mentioned liquor recovered on his shop under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest. The whole process of seizure and labelled was made in between 18.45 hrs to 19.15 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Raj Sunil Karmakar (28) S/O Mangru Karmakar of lichu pakri PS Fansidewa District Darjeeling and arrange for its investigation.
