I ASI Dhruba Mishra of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e. 27.10.21 at 14.15 hrs receive information that one Dilip Agarwal and Raju Das had been storing and selling the illegal fire crackers at the Shop cum Godawn situated at Mahabirsthan near Railway Gate under Siliguri PS. The matter was diarised vide Siliguri PS G.D.E no. 1739 dated 27.10.21. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S myself along with ASI Subir Sen, CV-283 Prosenjit Dey and CV-622 Ramanath Barman had been to the spot vide Siliguri P.S GDE no-1740 Dated: 27.10.21. As per source information we conducted raid against selling, storing of illegal fire crackers in the said godawn of Dilip Agarwal that he had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. During raid, we found that the above noted accused person was busy to sale the above noted seized articles. Accordingly I apprehended the above noted accused person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers kept concealed in the godown of Dilip Agarwal. But somehow the owner of said Shop cum Gadown namely Dilip Agarwal managed to escape from the spot.

On being asked the above noted accused person admitted his guilt of purchasing, storing and selling of fire crackers in this godawn without licence. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at this godown. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 14.45 hrs to 16.50 hrs.

Hence, I pray before you that a specific case may kindly be started against the above noted arrested person namely Raju Das (26 yrs) S/O Ratan Das of Ganga Nagar, Ward No.05,PS-Siliguri, Dist- Darjeeling and absconding person namely Dilip Agarwal S/O Late Sagarmal Agarwal of Milanpally near Children Park, Ward No. 25, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigation.
