Respected Sir,

I, Smt Sangita Saraogi, Wife of Sri Ashok Saraogi, Housewife, permanent resident of Shibmandir Road, behind City-Mall, near Upkar Medical Shop, bye lane-2, SARAOGI SADAN, Ward no.13 of Siliguri Municipal Corporation, Post Office Sevoke Road, Police Station-Siliguri, District Darjeeling like to inform you as follows:-

That to day(30/10/2021) at about 8.30 am I alone for marketing of household items, I started from my afore said home at punjabipar and walking through Shibmandir Road, I reached at Sevoke Road in front of M Bazar, City-Mall around 8.45 am for hiring one toto-riksha for moving towards Bidhan Market through Sevoke Road.

That when I trying to seat on the toto-riksha one person come nearby me and call me that his senior officer is calling me and when I asked him who are they he show one identity card of police and also said me that they are police personal in civil dress.

That thereafter the aforesaid person took me to the so-called senior police officer who was standing beside one motor bike at the shivmandir road in front of one closed pan-shop and mobile-shop beside one sweet shop (partly open).

That after reaching near to the so-called senior police officer he asked me to open my "bazar-bag", since he want to check it and I bound to hand over the bag to him for checking he then made a just casual look and search with his hand inside the bag and return the same.

Thereafter he looked after me and asked me to pay Rs.5000/- (Rupees Five Thousand) only as Government Fine for wearing valuable Gold Jewellery and original Diamond ornaments during Puja season from Durga Puja to Kali Puja as there is a government circular not to wear Original Gold and Diamonds Jewellery for prevention of snatching.

But since I have no sufficient money with me he along with the other person directed me to remove my Gold Chain along with one solid Pendent (Bajrangbali) engraved with 15 (fifteen) pieces of original diamonds (weight about 30gm approx) and two original gold bangles engraved with 09 (Nine) pieces of original diamonds in each bangles (weight about 35gm approx x 02 = 70gm approx).

That the aforesaid so-called police personal in civil dress give me one paper for wrapping the aforesaid Gold Chain along with one solid Pendent (Bajrangbali) engraved with 15 (fifteen) pieces of original diamonds (weight about 30gm approx) and two original gold bangles engraved with 09 (Nine) pieces of original diamonds in each bangles (weight about 35gm approx x 02 = 70gm approx) and help me to make one packet of the aforesaid Original Gold and diamond Jewellery and they put the said packet inside my "bazar-bag" and tighten the bag handles as security and told me to go return back to my home and keep the aforesaid Original Gold and diamond Jewellery in safe custody in my house.

I on good faith return to my house and open the aforesaid "bazar-bag" in front of my husband and children and found that there is no Gold Chain along with one solid Pendent (Bajrangbali) engraved with 15 (fifteen) pieces of original diamonds (weight about 30gm approx) and two original gold bangles engraved with 09 (Nine) pieces of original diamonds in each bangles (weight about 35gm approx x 02 = 70gm approx) but instead of those original Jewellery we found some fake 03 (three) metal golden bangles instead of my aforesaid original Gold Chain along with one solid Pendent (Bajrangbali) engraved with 15 (fifteen) pieces of original diamonds (weight about 30gm approx) and two original gold bangles engraved with 09 (Nine) pieces of original diamonds in each bangles (weight about 35gm approx x 02 = 70gm approx).

That I then realized that I have ben cheated by the aforesaid impersonated police personal in civil dress and my original Gold Chain alongwith one solid Pendent(Bajrangbali) engraved with 15(fifteen) pieces of original diamonds (weight about 30gm approx ) and two original gold bangles engraved with 09(Nine) pieces of original diamonds in each bangles ( weight about 35gm approx x 02 = 70gm approx) total money valuation more or less 09 (nine) Lakhs.

I hereby request you to look into this matter as expeditiously as possible and take necessary actions against the above-named two person who presented themselves as police personals in accordance with laws of the land.
