Then he promise me to marry with me and request to send me a naked photographs, and he had emotionally blackmailing me, after I send a photo, then he had viral my photo in messenger, and also send to my relatives and friends. I Told him to delete my photo, then he told me if I wanted to delete my photo then I have to be keep a physical relation with him then he will delete my photo from his phone and he also told me that he will marry with me. Therefore in the month of September 2021 he came to Siliguri, although he told me that he will marry with me, then I ready to keep a physical relation with him, we had physical relation. After a physical relation I was shocked that he took our sex video, and my and he did viral on face book, sent to all my friends relatives, and he also told me that he saved my video and photos in different pendrives and memory card. I told him to delete all the photos and video, then again he told me If I wanted to delete all the Photos and video then I will have to do several time physical relation with him.

Therefore sir I have no any option to go anywhere, he will break my trust I will never trust anyone, I am totally hopeless so I came to your office, sir kindly help me to delete my all photos and video, and give a punishment to that culprit.
