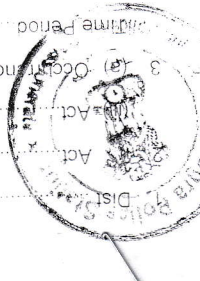

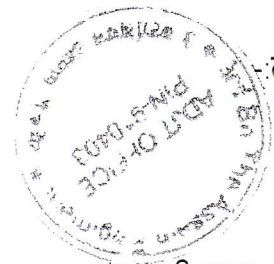
2. The unit recee team has instructed the indl to immediately remove the illegal construction.
